THE AUSTRALIAN TAX OFFICE IS NOT A LEGAL ENTITY ACCORDING TO THE HIGH COURT OF AUSTRALIA. MOELIKER . V. CHAPMAN. B/2000 (17 MAY 2000 )HCA. AS ALL HIGH COURT RULINGS MUST BE ENFORCED, SECTION 25, 1903 JUDICARY ACT, THEN THIS TREATY CANNOT BE LEGAL. THE MATTER MOELIKER, V. CHAPMAN WAS PERMANENTLY STAYED IN THE HIGH COURT OF AUSTRALIA. WHICH MEANS IT CANNOT LEGALLY ACT. THE AUSTRALIAN TAXATION OFFICE CANNOT APPEAR AS A PARTY IN THE HIGH COURT.
