AGREEMENT.

DEAR SIRs.


IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY BE RATIFIED, HOWEVER
ONCE AGAIN WE BRING IT TO THE ATTENTION OF THE PARLIAMENT THAT THE SO
CALLED NATION OF NEW ZEALAND IS IN FACT STILL LEGALLY PART OF AUSTRALIA,
BOTH UNDER THE COMMONWEALTH CONSTITUTION , AND UNDER NEW SOUTH WALES
LAW. AS THE 1914 FEDERAL CRIMES ACT , SECTION 24AA STATES THAT ANY ACT TO
OVERTHROW THE CONSTITUTION IS TREACHERY. IT WOULD BE IMPOSSIBLE UNDER THE
LAW TO HAVE A TREATY WITH OURSELVES . THE EXECUTIVE DO SUPPORT CLOSE TIES
WITH NATIONS IN OUR PACIFIC REGION. WE DO NOT SUPPORT THE WTO , NOR ANY OTHER
NEW WORLD ORDER BODY. THE EXECUTIVE HAVE ALWAYS CALLED FOR A FREE TRADE
BLOCK IN THE PACIFIC , BUT WITH RESERVATIONS. FOREIGN OWNERSHIP IS NOT IN THE
INTERESTS OF AUSTRALIA, WE CALL ON THE PARLIAMENT TO ADDRESS THE LINK TO
NEW ZEALAND BEFORE SUCH TREATIES ARE RATIFIED. A FEDERAL REFERENDUM IS
REQUIRED TO CHANGE N.S.W. LAW IN RELATION TO THIS MATTER . THE ESTIMATED LOSS
OF \$ 971 MILLION DOLLARS IN TARIFF REVENUE IS OF A MAJOR CONCERN TO THIS
EXECUTIVE , WE BELIEVE THAT MULTINATIONALS SHOULD PAY A TAX ON PROFITS ,
THEN THAT TARIFF LOSS COULD BE MADE UP. WE ALSO DO NOT AGREE TO THE COST
OF \$ 20 MILLION DOLLARS OVER FIVE YEARS FOR THE IMPLEMENTATION OF THE FTA
THAT WOULD MEAN THE TOTAL COST WOULD BE A LOSS OF \$ 991 MILLION DOLLARS,

ABOLISH THE LEGAL NON ENTITY CALLED THE AUSTRALIAN TAX OFFICE , (ATO) . REDUCE THE PUBLIC SERVICE , INTRODUCE THE JEREMY BENTHAM STYLE MANAGEMENT OF AUSTRALIA , THE LESS INVOLVEMENT BY PARLIAMENTS THE BETTER FOR SOCIETY .
