DEAR SIRs.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS NOT BE RATIFIED. THE EXECUTIVE DO NOT SUPPORT LEGAL ASSISTANCE FOR PEOPLE WHO COMMIT SERIOUS OFFENCES OUTSIDE OF AUSTRALIA. WE BELIEVE THE SAYING IF YOU COMMIT THE CRIME , THEN DO THE TIME. DRUG TRAFFICKERS , SHOULD BE EXECUTED THE DAY OF CONVICTION, FRAUD AND MONEY LAUNDERING , PEOPLE TRAFFICKERS SHOULD HAVE NO APPEAL PROCESS, NO CHANCE OF RELEASE.
