# Amendments to Appendices I and II of the Convention on the Conservation of Migratory Species of Wild Animals

# Question no: 1

Proof transcript page: TR20

### Mr John Murphy asked:

Do we know how many species of shark are protected presently under the EPBC Act?

#### Answer/s:

Currently 9 species are listed under Part 13 of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). These are:

Whale shark *Rhincodon typus* (listed as threatened and migratory)
Great white shark *Carcharodon carcharias* (listed as threatened)
Speartooth shark *Glyphis glyphis* (listed as threatened)
A river shark *Glyphis garricki* (listed as threatened)
Grey nurse shark *Carcharias taurus* (listed as threatened)
Longfin mako shark *Isurus paucus* (listed as migratory)
Shortfin mako shark *Isurus oxyrhynchus* (listed as migratory)
Porbeagle shark *Lamna nasus* (listed as migratory)
School shark *Galeorhinus galeus* (listed as conservation dependent).

### **Question no: 2**

Proof transcript page: TR20

#### Ms Melissa Parke asked:

**Ms PARKE**—During the consultation process, does the department normally consult with conservation and environment groups?

Mr Oxley—Yes, it does.

Ms PARKE—Was that done in this case?

Mr Oxley—Yes, it was.

Ms PARKE—With which particular groups?

**Mr Oxley**—I would have to take on notice the question of all of the groups that were consulted, but the Humane Society International was certainly one of those groups that were consulted in this process.

Ms PARKE—Thank you.

### Answer/s:

There are no records of consultations with NGOs on the Australian Government's position prior to the CoP meeting in December 2009. The Humane Society International (HSI) attended the meeting as a member of the Australian delegation. A condition of HSI's participation was a requirement to adhere to the Australian Government delegation brief.
