
IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS NOT BE RATIFIED,

BECAUSE OF FREE TRADE AGREEMENTS , TAKEOVERS AND A WEAK FORM

FOREIGN NATION WILL BE ALLOWED MORE THAN 48 PER CENT OWNERSHIP OF ANY AUSTRALIAN COMPANY , ALL FOREIGN NATIONALS WILL HAVE TO LIVE FOR FIVE YEARS AT THEIR OWN EXPENSE BEFORE RECEIVING WELFARE PAYMENTS . NO AUSTRALIAN WILL BE ALLOWED TO LIVE OVERSEAS AND RECEIVE WELFARE , NO MEMBER OF PARLIAMENT WILL BE ALLOWED TO TAKE A SECOND JOB AFTER LEAVING PARLIAMENT AND RECEIVE PENSIONS EQUAL TO WAGES RECEIVED WHILE IN PARLIAMENT.
