DEAR SIRS.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY BE RATIFIED, HOWEVER IT THE POLICY OF THIS EXECUTIVE THAT WE DO NOT TRUST MULTINATIONALS.

AS MULTINATIONALS AVOID TAXATION ON PROFITS IN AUSTRALIA, WE ARE WARY OF SUCH AGREEMENTS. INVESTMENT SHOULD COME FROM COMPANIES WHO ARE AUSTRALIAN OWNED, UNDER TAX INCENTIVES PROVIDED UNDER LAW.

WE DO NOT SUPPORT FOREIGN OWNERSHIP OF RESOURCES, PROPERTY, INVESTMENT COMPANIES, WATER, POWER, TRANSPORT, HEALTH, FOOD OR BANKING. IT IS OUR INTENTION IN THE FUTURE AS A PARLIAMENT TO INTRODUCE A DEBIT TAX OF ONE PER CENT ON ALL FINANCIAL TRANSACTIONS. THIS TAX WOULD RAISE 360 BILLION DOLLARS MORE THAN CURRENTLY RAISED, MULTINATIONALS WILL HAVE TO PAY A TAX OF SEVENTY CENTS IN THE DOLLAR, ON PROFITS. STRICT GUIDELINES ON INVESTMENTS NEED TO BE INTRODUCED, TO PROTECT OUR PEOPLE
