DEAR SIRS.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY SHOULD NOT BE RATIFIED. SEVERAL ERRORS HAVE BEEN MENTIONED AS TO LAW IN RELATION TO THIS TREATY. FIRST OF ALL THE AUSTRALIAN TAX OFFICE IS NOT A LEGAL ENTITY, THAT ADVICE COMES DIRECT FROM THE (ATO) THE ATO CANNOT APPEAR AS A PARTY IN THE HIGH COURT BECAUSE THEY ARE NOT A LEGAL ENTITY. ANOTHER FACT IS THAT ALL PROPERTY IN AUSTRALIA IS UNDER FEE SIMPLE TENURE, ACCORDING TO HIGH COURT RULINGS ALL MINERALS AND OIL UNDER THE GROUND BELONGS NOT TO THE CROWN BUT TO THE OWNER OF THE PROPERTY. ALSO THE HIGH COURT STATED THAT THE CROWN UNDER LAW IN AUSTRALIA IS FICTION. FEE SIMPLE IS COMPLETE ALIENATION FROM THE CROWN, AND THERE CAN BE NO PARTIAL ALIENATION ON FEE SIMPLE PROPERTY, FEE SIMPLE TENURE IS ALSO INTERNATIONAL LAW. ANYTHING OVER, ABOVE, BELOW, ON OR PART OF IS THE SOLE PROPERTY OF THE OWNER UNDER FEE SIMPLE TENURE. SECTION 25. 1903 JUDICARY ACT STATES THAT ALL HIGH
