Follow up from JSCM 24 February 2010 – HP answers

Question 1: What percentage of people who have been refused and who have appealed to the tribunal have then been successful in having their application overturned?

In 2008-09 Migration Review Tribunal (MRT) PIC 4005 decisions, 33 decisions were affirmed (43%) and 43 (57%) were remitted back to the Department (see Table below)

In 2008-09 MRT PIC 4006A decisions, 2 decisions were affirmed (33%) and 4 (66%) were remitted back to the Department.

In 2008-09 MRT PIC 4007 decisions, 2 were affirmed (13%) and 13 (87%) were remitted back to the Department.

In 2008-09 there were 24 MRT cases involving PIC 4005 that requested a Review Medical Officer of the Commonwealth (RMOC) opinion. Of these 24 cases, there were 13 cases where the RMOC opinion was different to the original Medical Officer of the Commonwealth (MOC) opinion (54%).

Question 2: Is Legend available publicly, do people get charged for access to it and if so how much?

Public access

Question 4: How many cases where health was refused was the 'sick' person a dependent child with a disability?

According to the Department's 2008-09 data, there were 44 people who were refused a visa because of some form of intellectual impairment. Of these, 26 were children. (the youngest 2 years, the oldest 15 years).
