Submission for the Inquiry into Multiculturalism in Australia

Submission

I believe multiculturalism can exist in Australia but it cannot be implemented in a blanket fashion allowing anyone and everyone to come into Australia. I am certainly not against multiculturalism, nor am I racist. I am a 3rd generation Australian and have married a French speaking European who has graciously integrated into the Australian culture, working hard, paying taxes, given the country 2 more beautiful kids and is more patriotic about Australia than her own country. This is the type of people I believe we need in this country.

From what I have seen, most nationalities and religions come to Australia for a better future. They bring a wealth of cultural positives and integrate, contributing to make Australia the fantastic place it is to live.

There is an exception to this, and I believe it comes in the form of Islam.

I have done sufficient research into Islam including reading many publications from ex-islamists, and the outcomes from my readings are frightening. What it has shown me is that Islam is far more than a religion, it's a political ideology that utilizes any means in order to propagate and infiltrate communities, governments and organizations in order to dominate and make its non peaceful agendas a reality.
