The Inquiry into 'Multiculturalism in Australia' Determining 'The Social Inclusion Agenda'! Must Australians Obey Sharia--not Law to 'Live in Harmony with Muslims?'

Honorable Chairperson,

Over view:

The purpose of this document is to compliment an earlier submission dated April 8, 2011 where the rationale is argued that the escalating divisions between the Australian and Muslim communities is directly related to the governments presently compromised Multicultural Policy (MC)

This submission is to consolidate the argument that Australian Muslims practicing their sect's faith with a doctrine that equates to the 'Rules of Sharia' are obeying Rules of Sharia laws with a theocratic Islamic system of government -not the States laws.

Professor Abdul Saeed in a government sponsored ;Manual' –'Muslim Australia' –'Living in Harmony'-describes the conditions Muslims will tolerate living in Australia-not how Muslims can -'assimilate- in Australia;

At present Muslims obey Sharia –not law in their colonies- and the division and conflict between the societies is when Australians protest at being forced to submit to Islamic Shari law.

On page 74 of the Manual is an 'Ultimatum' to the government – in essence it states if the government denies the Muslims who are presently practicing their religion and performing the basics of their religion in the public domain – that is they are practicing 'Rules of Sharia' declared incompatible with democracy by the ECHR—

- They will consider they are being persecuted because of their religion and be disloyal to the State
- That means pursuant to the Rules of Sharia we are an 'enemy'- and can expect to be dealt with under the Shari penal code – which justifies home front terror.

While the government follows its 'Politically Correct 'policy and tolerate Muslims to 'obey Sharia' and not law – we must submit to Islam and obey Sharia, not law, and be denied our fundamental rights.

Therefore the Inquiry must first determine if 'The role of multiculturalism in the Federal Governments social inclusion agenda'- will focus on assimilating either:

- Muslims living in harmony with Australians!--That is must they obey law-not 'Rules of Sharia?
- or will the governments role- continue with it's present toleration of Muslims obeying Rules of Sharia and not law (which submits to Professor Abdul Saeeds 'ultimatum')and a 'Politically Correct' policy that assimilates :
- Australians living in harmony with Muslims where the people submit to Islam that is we must obey Rules of Sharia-not law- and the government continues to deny its responsibility to uphold Australians fundamental rights?

Sharia obligates the sect's follower's allegiance and loyalty to a foreign government – their loyalty to the State is meaningless

The argument that the policy is not adapted to Muslim migrants being allegiant and loyal to a Foreign Islamic government, and it is also responsible for encouraging Australian Muslims to obey Sharia and not our laws.

. The most significant issue contributing to the multicultural policy's failure is directly related to the Hawke Labor governments 'special Interest' deal with Sheikh El Hilaly and the Lebanese Muslim Association council- the administrators of the Lakemba Mosque-which not only left the Hawke government and the Sheikh still in power but also left the Sheikh the responsibility of assimilating its 300,000 ethnic voters with Australians and be loyal to the host whilst obeying Sharia –Not possible!

That is a foreign system of government-being rules of Sharia that specifically denies assimilation and loyalty to any other government is controlling the MC policy agenda!

We are not surprised by this outcome!

We uphold a statement by 'Daniel Pipes' a political observer in the US quote: 'Unfolding for a long time across the Western world, through the creation of <u>isolated Muslim</u> <u>enclaves</u> in both rural and urban areas, as well as through the designation of "<u>no-go</u> <u>zones</u>" where governments admit to having little authority over Muslims living there, essentially leaving them to function as autonomous regions.

We believe that this 'hands off policy' accurately depicts our governments present behaviour and why it is derelict in its duties in upholding the peoples rights.

We argue that the inquiry cannot adapt the present MC policy to assert assimilation with and loyalty to the State- unless it resumes control of the Muslim Migrants Social Inclusion agenda from the Lakemba Mosque. or any other self determining Mosque or entity. ASIO has no hope of protecting the rights of all Australian citizens with a Multicultural Policy that is in the hands of foreign governments and whose doctrines obligates followers to obey Sharia that readily supports home front terror.

The governments sabotaged Multicultural policy is as much to blame for fostering home front terror as any other issue noted in the 'Counter Terrorism White Paper 2010' which states "

"in our efforts to combat terrorism we also protect the rights of all Australians"

We believe there is a consensus among the majority of the Australian multicultural community that unless the governments causes law for the same reasons that EU has been forced to enable basically replicating Ataturk's pre 2007 Constitution(now compromised) that separates 'Church from State', (all the arguments and options put to the inquiry in the first submission are upheld by this submission).- we will surely escalate into the same social chaos that other governments are globally experiencing.

We argue that it is vital for our society's ability to be able to maintain a MC policy that will promote assimilation and loyalty of our immigrants to the State as was maintained prior to the influx of Muslim immigrants...

As such the MC policy and its agenda should possibly be considered as a matter for a national referendum!

To date the government is derelict in its duties in upholding the constitutional rights of the people and it does not have constitutional authority, to deal with foreign states except arguably as a 'external affair' of Part IV 44 (xxix)of our Constitution- 'for causing laws for ' peace, order, and good government'

This situation we have is a foreign Islamic government arbitrarily annexing sovereign territory to practice a system of 'Sharia' government based on the notion of a 'plurality of legal systems, grounded on religion' which was ruled in 2003 to contravene the European Convention for the Protection of Human Rights Constitution.

The Lakemba Mosques alleged fundamental doctrine equates to the Turkish Refah Parties Sharia rule platform.

Quote:

The European Court of Human Rights determined that "sharia is incompatible with the fundamental principles of democracy".^{[160][161][162]} Refah's Sharia based notion of a "plurality of legal systems, grounded on religion" was ruled to contravene the European Convention for the Protection of Human Rights and Fundamental Freedoms 'Quote

In 1998 the <u>Constitutional Court of Turkey</u> banned and dissolved Turkey's <u>Refah Party</u> on the grounds that the "rules of sharia", which Refah sought to introduce, "were incompatible with the democratic regime," stating that "Democracy is the antithesis of sharia." On appeal by Refah the European Court of Human Rights determined that "sharia is incompatible with the fundamental principles of democracy". ^{[160][161][162]} Refah's Sharia based notion of a "plurality of legal systems,

grounded on religion" was ruled to contravene the <u>European Convention for the Protection of</u> <u>Human Rights and Fundamental Freedoms</u> (ECHR)Unquote

Note 1)"Article 18 Freedom of religion and belief (1998)

This report addresses the human right to freedom of religion and belief in Australia under article 18 of the International Covenant on Civil and Political Rights. The right includes the freedom to have or adopt a religion or belief of one's choice, including theistic, non-theistic and atheistic beliefs.

The freedom of religion and belief extends to the right to manifest one's religion or belief in worship, observance, practice and teaching. The right to manifest a belief is subject only to limitations provided by law which are necessary to protect public safety, order, health or morals or the fundamental rights and freedoms of others."Note 1)"Article 18 Freedom of religion and belief (1998)

The EU has customized their laws to ban minarets and Mosques being built in capital on the grounds that while Muslims obey Sharia and not laws Mosques and minarets are not indicative of a place of worship but political institutions with a will to rule.

As in the EU, the UK, the US and most other western nations with Muslim Immigrants Australia has exactly the same problems- however ours are exacerbated by the Hawke Labor government's legacy.

The government's toleration of a de facto Islamic state is well documented in the previous April 8 submission

We argue that the government is derelict in its duties to uphold the Constitution on the following grounds

- Undeniably-Muslims are practicing their religion and performing the basics of their religion in the public domain – That is they are practicing 'rules of Sharia' declared incompatible with democracy by the ECHR—
- Practicing Rules of Sharia –a system of a foreign government violates the conditions that limit the 'freedom to practice ones belief, worship, and observance of a faith or belief
- Practicing and teaching as the right to manifest that belief does not include 'Rules of Sharia '
- Sharia is in fact a system of rule that guides all devout Muslims throughout their lives from the time of their birth to their death'-a system of government based on a notion of a 'plurality of legal systems, grounded on religion, that infringes on other peoples rights and violates article 18 of the Declaration of Human Rights
- A follower is directed how to behave in compliance with a rule of Shari which has a penal code for any transgression by any person.

- This violates Article 18 as it is necessary to protect the public safety, order, health or morals or the fundamental rights and freedoms of others that the Shari penal code may affect
- This threat includes verbal 'fatwa's' and 'jihad'
- The government is duty bound to cause laws to uphold all people's sovereign rights and protect the public safety, order, health or morals!
- The freedom of wearing of clothes of ones choice is also violated as wearing certain oppressive clothes in public are considered by modern Muslims as "a grave misunderstanding of Islam by extremist sect followers who are manipulated by their respective sect to believe it is an expression of faith"- and is not worn by choice but of fear if not worn will affect their salvation on judgment day. - There is no choice!
- The urging in Fundamental Islamic Dress Code websites to adopt the face veil with prayer Abaya garments (Burka style) is noted in some sites to urge other than Salafist sect worshippers to wear the veil as the most effective protest against the west but mostly we are the 'enemy'-Nobody knows just who is lurking in a Burqa!
- The wearing of these garments are prohibited in Mecca during 'hajj'
- Hajj is as all people (rich and poor) wear the same simple two pieces of plain cloth for the duration of hajj: - where every one must be equal and show solidarity with modest head clothes
- The best way to debunk the Burqa as an expression of Muslim faith is to listen to Muslims who oppose it!-
- The government does not have the constitutional power to tolerate any entity or foreign government to arbitrarily annex squatted sovereign territory and self determine authority and practice government over that territory for any purpose including any faith or belief.
- There is only one 'head of power' in our country and that's the State- so its time to establish just who's who!
- The SW Sydney Muslim colony was recognized by the Hawke Labor in its 'power sharing barter in 1988 as being under the control of the Lakemba Mosque Imam Sheikh El Hilaly.
- The practicing and performing of the basics of their religion to their Shari is being performed in public and those non believers who may be critical or inadvertently violate a rule of Shari are subjected to harassment and violence having their rights infringed upon on a daily basis by Fundamental Muslims
- The Shari followers demand that their rules of Shari be submitted to –and a No Go Zone for westerners is occurring.
- The SW Sydney Muslim colony is a de facto Islamic state and the No Go Zones have already attracted calls for official recognition-
- · Fundamentalist doctrine includes the political will to rule
- It is the inquiry's responsibility to determine what the Muslim community can display that would preclude the government from causing the EU and Muslim countries laws to regulate the Fundamentalists will to rule

British Prime Minister David Cameron noted late last year when he condemned his country's long-standing policy of multiculturalism as a failure, saying it was partly to blame for fostering Islamist extremism.

We have been told by the Counter Terrorism white paper to expect –home front terror from local radicalizing Australian Muslims.

We have seen <u>Abdul Nacer Benbrika</u>, Sheik El Hilaly and other ranting radicals inciting racial hatred and refusing to condemn suicide terror- and while the Australian Muslims obey Sharia and not our laws- this threat will escalate.



Abdul Nacer Benbrika-A good candidate for only being issued a Permanent 'Revocable ' Visa -

With a 'citizen ship' he is fireproof- goes to jail and radicalizes 'inmates'!-

Issued a 'Revocable ' Visa' and for this nonense he's out!

Our Multi cultural policy is as much to blame for fostering home front terror as any other issue noted in the 'Counter Terrorism White Paper 2010' which states "

Quote "in our efforts to combat terrorism we also protect the rights of all Australians"

ASIO has no hope of protecting the rights of all Australian citizens with a Multicultural Policy that promotes the Muslim community to be allegiant and loyal to a foreign government- and tolerates Muslims obeying Sharia and not our laws

The ultimate humiliation is the issue of an 'ultimatum' to the government as Professor Abdul Saeed has done on behalf of a 'cock sure' Muslim community that states in effect-Don't rock the boat or else!(P74 Muslim Australia)

Make no mistake the governments policy is a significant contributor to fostering home front extremism and relying on 'tip offs' in no way resolves the cause of this home front radicalizing of Australian Muslims.

It worries us greatly to see our society being separated by religion and as our constitution separates the church from the state –whilst it is not as clear a way as the US or France, never the less there are safeguards in there-and it still should work!

To date we see in Muslim colonies in Australia -- that the 'Church rules the State!'

Why can't we live together? - We are OK with Turks! Why not Lebanese?

Must we be denied our fundamental rights for Muslims to live as peaceful neighbors?

Honorable Chairperson,

Over view:

The vexing problem that all nations, both Muslim and non Muslim nations have experienced with Muslim migrants of Fundamentalist+/extremist ethnic groups and various sects finds that Fundamentalists with obsessive loyalty to their sects theocratic Islam governance and the sects customized Sharia laws cannot assimilate or hold co existent loyalty with their hosts.

All Australian Muslims must obey the law-not Sharia!

We believe 'All Australian Muslims must obey the law-not Sharia! Being the most divisive issue between the western democratic society and the Muslim community...

This fundamental principle needs to be resolved by the 'Inquiry' to enable the government to redeem our Multicultural Policy and to upgrade same if needed so it represents good government--promoting all migrants to assimilate and be loyal to the state

The number of Muslims who take the oath of allegiance to the 'Flag' that cannot co exist with their over riding allegiance to a Foreign government sees them obeying Sharia- in precedence to the law.

This situation should be addressed by issuing 'Revocable' or 'Redeemable' Permanent Visas.

A 'Permanent Visa' should be issued to Muslims in two classes:

- c) Fundamentalist Muslims from countries where Muslims obey Sharia and they are replicating a Sharia based ideology that conflicts with our democratic law should only be issued a 'Revocable Visa' which is not redeemable for citizenship –
 - Any hostile anti western behavior, practicing of Sharia law that affects the fundamental rights of 'other people, is seditious, incites racial hatred, is associated with home front terror basically not assimilating etc –they can be deported-

- It is essential that Fundamentalists are not 'fireproof' and do not have the security of a 'citizenship' if they do not 'assimilate' .or honor their loyalty.
- The 'Clerics' hold the key to the 'Harmonizing' of our societies- in essence- 'War' or 'Peace'!-
 - If a migrant 'Cleric; has a history of inciting 'race hatred' or has been promoting an ideology that denies 'assimilation' then only a ' Revocable' Permanent Visa should be issued - - Act on the 'safe side'!-
 - o Why should they be trusted with their 'Islamic License;?
- d) Liberal Moderate Muslims from counties with Muslim secular government that practice Liberal Secular ideology that replicates Ataturks Constitutional ideology separating the Church from the State e.g. Turkey, Tunisia, etc should be issued with a ;Permanent Visa' that is 'Redeemable' for a 'citizenship' application.
 - The qualifying period should be extended in case we have a deregulated Fundamentalist Muslim a 'ring in' who was acting as a Liberal Muslim in Turkey but is now in Australia de regulated and a resurrected Ottoman Caliphate Fundamentalist Muslim. (Islamic license '<u>Did I say that!</u>)
 - After 2007 there is a distinct possibility that we get Ottoman Muslims.

Rules of Sharia! - A "Plurality of legal systems, grounded on religion"

The Path

Islam is more than a Religion; it is in fact a system of rule that guides all devout Muslims throughout their lives from the time of their birth to their death.

We believe that there are only two policies available to the inquiry to resolve the escalating division between our societies.

- Indian 'Composite Nationalism Policy (Nehru)- the 'Assimilation Model' Or
- Ataturk Constitution separating the church from the state-'the Accommodation Model'-The 'French Resolution'!

Practicing fundamentalist ideology gives the clerics and the Mosque administrators too much power- as it can swing from moderate to radical –verbally.

Rules of Sharia – The Path. Practicing this system of rule violates <u>Article 18</u> of the Declaration of Human Rights (See appeal against Refah Party Ban upheld (<u>Refah Note 2</u>)

The Fundamentalist Path is undemocratic – the dark ages-The church is the state!

Atataturks Liberal secular Path- This is democratic ideology and separates the church from the state

Arguments, Options, and Research

1 The Purpose

The purpose the 'Orange Paper' submission is to provide compelling argument that the inquiry should determine what conditions or behavior can the Muslim community display that would preclude the EU and Muslim countries laws being replicated in order to curb the anti western social behavior that is predominantly practicing Sharia systems of rule

2 The Cause of Islmophobia

We live in fear of Islam in Australia as in other western countries all with migrant Muslims, including the EU having been under siege from a Rise of Islam

These countries and others are now adopting the Turkish and other Muslim secular governments Potsdam Accord principle laws

3 Co existence of Loyalties?

Loyalty and allegiance only to a foreign government with a political will to rule has required Fundamental Muslims to be regulated to maintain a secular modernist Islamic ideology.

The EU regulates migration to control social misbehavior, segregation, and exploitation of social welfare.

4- Our options- Is the Church separated from or integral with the state

The Federal Governments 'Migrant Social Inclusion' agenda must address the Muslim ethnic migrant inclusion policy to accommodate whether the policy will favor: /

- Muslims following the Indian 'Composite Nationalism Policy (Nehru) the 'Assimilation Model' which recognizes an Islamic State –where the church is the state-under autonomous theocratic Islamic governance with chauvinist Sharia law that violates our constitution and human rights – that is no meaningful social inclusion – and loyalty only to a foreign government ,-or
- Whether Muslims follow the 1934 Ataturk Constitution separating the church from the state-'the Accommodation Model' –where: :
 - Muslims reconcile their faith and embrace the values of our secular state with modernistic interpretation of Islam to harmonize with our multicultural society and be loyal to the State'

5.-Modernist Muslims say-The 'Bunkum Burqa'!

The 'wearing of the Burqa' is claimed as a democratic right by the Fundamental Muslims!-This is opposed by modernist Muslims the EU and their governments.



The best way to debunk (Bunkum) the Burqa as an expression of Muslim faith is to listen to Muslims who oppose it!-

 Quran is very clear about the dress code for the believers. Innovations and fabrication introduced Hijab (veil) to Islam (submission.) Hijab (veil) is a traditional, not religious head cover that dates back to ancient civilizations, and is not supported or advocated by the Quran. –

6- A 'Duty of Care'!

We believe the inquiry has a duty of care to view banning the Burqa (Abaya) on the grounds the wearing of the Burqa and ilk garments violates <u>article</u> 18 of the declaration of human rights

We believe that there is overwhelming evidence from Burqa wearer's behavior that concurs with the Muslim and EU countries that supports either banning or counselling Burqa wearers to 'say no'!-as the garments are not worn to display piety or modesty but are a political symbol of a will to rule

Whilst we are aware that the genuine wearer is normally a 'generic heritage' we believe as with Modern Muslim countries with Sharia government who counsel the wearer to say 'No'

'An invitation by the government to come out of the 'dark ages'' is a responsible and understanding response to the States responsibility in upholding the wearers fundamental rights –rights that are denied from a 'generic obligation' that has never been questioned! (See Sergio's Statement Newtown Mural <u>Sergio</u>)



'Say No to the Burga'-An invitation!

Many Muslim governments know something that we in the West are today learning the hard way.

The best way to debunk (Bunkum) the Burqa as an expression of Muslim faith is to listen to Muslims who oppose it!- (Quran) (faith)

9. Assessing Hostile Doctrine

In order for the Ataturk model to be effective the Mosque sermons were censored (1934) and only the modern westernized liberal secular doctrine was permitted.

Whilst the government doesn't have this ability censor sermons and Mosque behavior per se-to adopt the 'accommodation model would require the Mosque ethnic group sects administration councils being assessed

The administrators (The ethnic groups Associations)or their employees (e.g. The Imam) should refrain from preaching or distributing hostile doctrine that equates to customized Refah Parties rules of Sharia doctrine (refer <u>Refah</u> Note # 2) banned by Turkey in 1998 and declared undemocratic by the ECHR in 2003,

The past behavior of Imams or other spokespersons that promote hostile anti western seditious rhetoric (that incite racial hatred and radicalized Australian citizens (as the Sheikh El Hilaly did) – segregates the community promoting hostile behavior. Such persons should be deported and the ethnic group councils responsible for importing and installing clerics- banned- !

If a Mosque has peaceful intent and has a will to integrate they need to worship/ teach /observe Liberal secular Muslim ideology.

10. The doctrine capability assessment for a Mosque should include"

- Is the performing of an Islamic doctrine demanding allegiance is first and foremost to a foreign government? and
- Does the sects Sharia law obligate them to perform the basics of their religion, their religious customs and traditions in the state—that is not only in the Mosque but in sovereign territory
- Are their any infringements on other people's rights? and customs performing in the state?? and
- Are such practices compromised to mutually respect other peoples rights in our multicultural society
- The present behavior where any denial or criticism regarding their religious demands infringing on their sovereign rights is taken as oppressing them or persecuting them because of their religion requires the Mosque to adopt Ataturks modern Liberal ideology
- Performing the basics of their religion without compromise toleration, or mutual respect, in public, in our society, is a major cause of dissension.
- The classing of unbelievers responsible for any denials are classed as 'enemies of Islam' and are subject to the penal code of Sharia-requires that Sharia law must be replaced with secular law and governance...
- Unless an Ataturk or EU liberal democratic ideology is adopted the present behavior b that infringes on other peoples fundamental tights is which violates Article 18 of the Declaration of Human rights will continue!
 The Muslims will go further left-and we will go further right!-
- Co existent loyalties are not permitted in Shari law!-and where Assimilation and loyalty to the 'enemy' is not permitted!-can be minimized by adopting liberal ideology negating Shari law.
- After all! If the Mufti can 'fatwa' to kill! He can 'fatwa' for peace! he is the messenger of God – the duty 'demagogue'!

Any ethnic group administering a Mosque that practices hostile Shari law
 -should be banned and any Imam who doesn't support liberal ideology
 should be deported or banned from preaching or inciting seditious or anti
 western racist material. We want neighbors like the Turks!

11 Anti Muslim prejudice among Australians is 'Reactionary' Anti Muslim prejudice among Australians is 'reactionary'!–

We are not proactive racists!!

Our anti Muslim prejudices are an aggravated response to a class of Muslim- minorityfundamental extremists that are hostile to our way of life – and threaten us with violence.

The manifestation of Islamic fundamentalist extremism in communities where followers with allegiance and loyalty to foreign Islamic governments victimize Australian citizens based on race and religion, and clerics with a history of inciting racial hatred and radicalizing Australian Muslims maximizes our fear of home front terror.

Such behavior traduces the reputation of the 'good guys'-the Moderate Muslims.! Why not support the 'good guys' and apply the regulations of Muslim countries who oppose this 'extremism'?-

That means our Mosques must adapt to Ataturks liberal westernized Islam and:

"Reconcile their faith and embrace the values of our secular state not 'embrace the values of the Lakemba Mosque Sharia Islamic State!

12 Make No Mistake Who the Racists are!

There is only one significant lot of proactive racists in our country and they are those fundamental Muslims that are allegiant to their Mosque's foreign government ruled by Sharia law in their de facto caliphate by courtesy of Bob Hawke and Paul Keating!

Without a shred of doubt we are the 'victims' not the. 'offenders'!

Islam can only forge ahead while it brands us 'racists'- and the governments PC protects them!-

Make no mistake! -- the governments PC have disabled our fundamental rights and freedoms! -- its time for redemption!

13 Squatted Territory is annexed as 'open Air 'Prayer venues- (Prayer Sites) The most significant division between our societies has been practising their religion; that is, preventing them from performing the basics of their religion, oppressing them or persecuting them because of their religion'

Whilst the Burqa is the cause of much of the significant confrontations it is often other people going peacefully about their daily routines and pleasure being harassed,

persecuted, threatened and subjected to violence mostly by gangs of Lebanese youths. - (refer <u>Salami</u>, <u>Headscarf</u>, <u>Rape</u>, <u>Defamation –Burga</u>)

14 A few 'tip of the iceberg No Go Zone' examples-(Most traceable to Sheikh El Hilaly statements mostly in 'Arabic'.

'The Salami Sandwich-Ramadan'

The public school at Punchbowl where the 'salami sandwich lunch boy was beaten up for eating during Ramadan by a gang of Muslim students – is a clear case of hostile anti western Muslim racism- Our son was subjected to similar bullying at Punchbowl 20 years ago,

Note of Interest –Home Front Terror 1915

On New Years Day 1915, the Local Branch of the Manchester unity Order of Oddfellows was to celebrate its annual picnic. At 10 o'clock the picnickers set out, pack in a train of ore-trucks on the Silverton Tramway.

The train had gone only two miles when an ice-cream cart flying the Turkish flag was noticed beside the railway line. Nearby on the bank of the long pipeline, from Umberumberka dam were two men with rifles. Originally thought to be shooting rabbits, the two men were pouring their gunfire into the crowed ore trucks.

Three Picnickers died – one woman and two men – and another six were seriously injured.

The two gunmen were locals of Indian/Afghan origin and Turkish Sympathisers. The elder was Mullah 'Abdullah, a long-time Broken Hill butcher, and the younger was Goal Mahammed, an ice-cream vendor.
