Dear Sir

I am delighted that the Honey-Bee Industry has at last been recognized as of great importance to Australia's Food Crops. Pollination for Horticulture and Agriculture Industries Crops.

What Bee-Farmers must have is access for managed Bees in Parks, Reserved Forests, Freehold Land for Honey Production, and to maintain bees in good condition for Pollination as 60% of Australia's food crops depend on Bees.

The time is coming when more young people will be needed for this industry, most Apiculturists are an aging lot. The Government needs to have Agriculture taught in Schools.

Disease needs more funding; if Varroa Mite is found in Australia, the Industry needs to be prepared as the same thing that happened in N.Z. won't happen here.

Research on other diseases Nosema, Apis Cerana (not in Australia)

Bushfires are a big hazard for Bee hives in the forest. fuel reduction burning on a regular pattern will be a benefit. Summer flowering Iron-Bark is a very valuable Honey-tree also a heavy yielder of Honey.

Because so much Forest is locked up, no cuttings in N.S.W. & T.S. Reserved Forest area is much smaller and cutting of this tree has increased. Bee-Keepers would like this species protected for Bee-keeping, or reduced other species.

The Future for Commercial Beekeeping in Australia is good, as Pollination will be much bigger than it is today. Almond growers will require 150,000 hives by 2010, and demand for bees for other growers will increase also.

A.F.B. is still a disease, needs work, to make sure ones bees are healthy. Bee-Smart sending samples of Honey from each yard of hives to Grubbs Pathology is a great help;

It would be a good thing if the Government set up a Queen-Bee breeding programme to breed disease resistant bees.

The general public need to be informed that introduced Honey-Bees belong in Australia's Environment, and for Australia to move ahead into the future managed Honey Bees must be a part of it.
