### SUPPLEMENTARY SUBMISSION TO THE STATEMENT OF EVIDENCE

#### Update to the Statement of Evidence

1. I wish to update the Statement of Evidence provided to the Committee in relation to referral of the project under the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). On 31 January 2013 we received advice from the Department of Sustainability, Environment, Water, Population and Communities (SEWPaC) that the proposed action is not a controlled action provided that it is taken in accordance with the manner described in the decision document. The Department of Finance and Deregulation (Finance) and the Department of Agriculture Fisheries and Forestry (DAFF) have confirmed that the action will be taken in accordance with the manner described. The described manner relates to the protection of Natural Temperate Grassland which exists on the site and the management of noise which may be created by the activities of the facility.

Decision on referral Post-Entry Quarantine Facilities Project, Victoria (EPBC 2012/6586)

Thank you for submitting a referral under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). This is to advise you of my decision about the proposed action to construct and operate a Post-Entry Quarantine Facility in Mickleham, Victoria.

As a delegate of the Minister for Sustainability, Environment, Water, Population and Communities, I have decided that the proposed action is not a controlled action, provided it is taken in accordance with the manner described in the enclosed decision document. This means that, provided that the action is undertaken in that way, it does not require further assessment and approval under the EPBC Act before it can proceed.

A copy of the document recording this decision is enclosed. This document will be published on the department's website.

Please note that this decision relates only to the specific matters protected under Chapter 2 of the EPBC Act.

This decision does not affect any requirement for separate state or local government environment assessment and approvals of the proposed action.

Please notify this department immediately if you are unable to undertake the proposed action in accordance with the measures described. Penalty provisions may apply if the referred action is undertaken in a different way to the manner specified.

Otherwise we would appreciate receiving your written advice:

- within two weeks of the date of this letter confirming that the action will be undertaken in the manner set out in the enclosed decision, and
- within three months of the date of this letter reporting on your progress in implementing the measures.

The department has an active audit program for proposals that have been referred under the EPBC Act. The audit program aims to ensure that there is a high degree of compliance with decisions made in relation to those proposals. Please note that your project may be selected for audit by the department at any time and all related records and documents may be subject to scrutiny. Information about the department's compliance monitoring and auditing program is enclosed.

I have written separately to the co-proponent, Mr Peter Moore from the Department of Agriculture, Fisheries and Forestry advising them of this decision.

which proposed action must be taken	Listed threatened species and communities (sections 18 & 18A), specifically Natural Temperate Grassland of the Victorian Volcanic Plain; and
	Commonwealth actions (section 28), specifically an action by the

Agriculture, Fisheries and Forestry.

- The person taking the action must not remove or reduce the extent of the 1.43 hectare area of Natural Temperate Grassland of the Victorian Volcanic Plain identified as NTGVVP in Attachment 2.
- 2. Prior to the commencement of works, the person taking the action must create a conservation area, by installing permanent fencing around the Natural Temperate Grassland of the Victorian Volcanic Plain and the Creekline Tussock Grassland, identified as NTGVVP and Creekline Tussock Grassland patch A in Attachment 2. The conservation area must incorporate, at a minimum, a 25 metre buffer zone around the Natural Temperate Grassland of the Victorian Volcanic Plain and Creekline Tussock Grassland patch A, except along the eastern boundary of Creekline Tussock Grassland patch A, which must be a 5 metre buffer zone. The permanent fencing must be maintained for the duration of works.
- 3. To minimise impacts to Natural Temperate Grassland of the Victorian Volcanic Plain and Creekline Tussock Grassland, the person taking the action must implement the following measures:
  - a. Prior to commencement of **works**, install signage on the **permanent fencing** enclosing the **conservation area** and maintain the signage for the duration of **works**;
  - b. Prior to the commencement of **works**, advise all contractors of the **conservation area**;
  - c. All personnel footwear must be **clean** prior to entering the **conservation area** to minimise the spread of weeds;
  - d. Undertake an ecological disturbance regime within the conservation area as approved by a qualified ecologist for the duration of works; and
  - Undertake weed control within the conservation area in a manner approved by a qualified ecologist for the duration of works.
- 4. To minimise noise impacts on **existing and future receivers** the person taking the action must:
  - a. Undertake works in compliance with the intent of the Victorian State Government Noise Control Guidelines (Publication 1254) (EPA, October 2008) and the State Environment Protection Policy (Control of Noise from Commerce, Industry and Trade) No. N-1; and
  - b. Before any dog is housed at the facility, the person taking the action must construct an impervious noise barrier along the eastern side of the Project Site Boundary adjacent to Building 9 Dog Compound, as identified in Attachment 2, to reduce noise impacts on existing and future receivers below the noise limits outlined in the guidelines in 4.a.

#### **Definitions:**

Clean means free from dirt, mud, seeds and other vegetative material.

**Conservation area** means the area labelled as grassland buffer zone and protection fence in Attachment 2.

**Creekline Tussock Grassland** means the Victorian Ecological Vegetation Class 654.

Existing and future receivers means the residential properties to the south of the Project Site Boundary, and the potential landholdings to the east of the Project Site Boundary.

**Impervious noise barrier** means a structure constructed to reduce noise impacts.

Natural Temperate Grassland of the Victorian Volcanic Plain means the ecological community listed as critically endangered under the Environment Protection and Biodiversity Conservation Act 1999.

Permanent fencing means stock proof fencing.

Project Site Boundary means the area identified in red at Attachment 1.

Qualified ecologist means a grassland ecologist with tertiary studies in ecology.

Weed control means selective spot spraying of weeds.

Works means construction and operation activities associated with the Post-Entry Quarantine Facilities Project, but excluding permanent fencing.
