Report on outdoor advertising to be tabled on Monday

The House of Representatives Standing Committee on Social Policy and Legal Affairs will table its report, *Reclaiming Public Space: Inquiry into the regulation of billboard and outdoor advertising*, at 10.30am on Monday, 4 July 2011. The Committee Chair, Mr Graham Perrett MP, and Deputy Chair, the Hon. Judi Moylan MP, will speak to the report in the Chamber. A press conference will follow at 12.15pm in Committee Room 1R2.

The Committee conducted the inquiry to investigate whether the current self-regulatory system for advertising is effective for outdoor advertising in particular.

Mr Perrett said, "Outdoor advertising is different to TV, print, radio and internet advertising in a fundamental way: there is no choice to view it or control children's exposure to it."

The report discusses community concerns about outdoor advertising, such as unwanted or inappropriate exposure to sexualised images and wording. The Committee investigated ways to address these concerns responsibly and practically.

The Committee found that the issue of 'community standards' was at the heart of many debates about advertising content. The report makes recommendations about adequately defining and ascertaining community standards, as this is an important issue that many in the community feel strongly about.
