## **Inquiry into Indigenous Employment**

I am writing on behalf of the researchers working on the Australia Research Council Linkage Project: Agreements, Treaties and Negotiated Settlements: Their role and relevance to Indigenous Australians in Settler States. Whilst we are unable to comment directly on initiatives relating to Indigenous Employment that have been successful, outcomes of our project can shed some light on where employment and training opportunities are being included in agreements made with Indigenous peoples around Australia.

The Project which began in January 2002 was developed to examine treaty and agreement-making with Indigenous Australians and the nature of the cultural, social and legal rights encompassed by past, present and potential agreements and treaties. The project involves researchers from both The University of Melbourne (Professor Marcia Langton, Chair of Indigenous Studies, and Assoc. Professor Maureen Tehan of the Faculty of Law, and Dr Lisa Palmer, Postdoctoral Research Fellow) and The University of Technology Sydney (Professor Larissa Behrendt of the Faculty of Law and Jumbunna Indigenous House of Learning). The project is also supported by the Office of Indigenous Policy Coordination and the Australian Institute of Aboriginal and Torres Strait Islander Studies.

A significant outcome of the project is the ATNS database (www.atns.net.au), an online gateway and resource that links current information, historical detail and published material relating to agreements made between Indigenous people and others in Australia and overseas. Designed for use by Indigenous and other community organisations, researchers, government and industry bodies, the ATNS database includes information on agreements relating to land, as well as those made in the areas of health, education, research, policy and Indigenous relations.

To date the ATNS project team has accumulated a significant quantity of data relating to agreements and the organisations, agencies, corporations and legislative frameworks that are involved in the process of agreement making between Indigenous people. There are over 2200 entities and published resources in the database of which approximately 560 are agreements. Wherever possible entries about these agreements

contain information relating to agreement provisions such as the employment and training, education, and business opportunities. The database includes only information that is already available in the public domain in some form or information given to us by parties who have given us permission to include it in the database. The database does not contain confidential information.

Of the 560 agreements detailed in the database, 475 are agreements that have been made in Australia. 108 of those contain employment and training provisions reflecting the high priority accorded to job creation for Indigenous people by the parties, especially between 1995 and 2004. A list of these has been provided for you as an attachment. Below is a chart detailing the number of Australian agreements which include employment and training provisions in 5 year periods from 1975 to 2004.
