To the House of Representatives Standing Committee on Communications, Information Technology and the Arts

RE: Inquiry into Community Broadcasting:

Background:

Ethnic Community Broadcasting through Canberra Multicultural Service (1CMS):

- We currently broadcast in 30+ languages weekly. (see attached form for more info)
- We estimate that we reach regularly on a weekly basis 28,000 people in Canberra and the region.
- We reach both longer established and emerging communities in the ACT and region. Each ethnic
 community has its own listeners profile, depending on the levels of English spoken in the particular
 community; the length of residence in Australia; the general age structure; and access to alternative
 sources of information.
- Programs typically provide a mix of general news, local information, information on government services
 and government initiatives; they also support cultural maintenance. Particularly for people with low levels
 of English they provide a link to the local community in general.
- Programs are typically produced and presented by volunteers who are required to demonstrate that they
 are responsive to their respective listening audiences. The station is run on a cooperative basis by
 representatives from the various languages programs (unpaid volunteers).
- We have consistently supported youth programming, by encouraging young people to participate as well as by providing broadcasting time especially for youth.
- We also offer access to other community groups and interests such as Community @ Work, and indigenous broadcasting. We also rebroadcast some interstate/international programs.
- Digital radio has the capacity to be more interactive than analogue broadcasts and has improvements
 over analogue sounds including improved quality, greater choice, interference free reception, no retuning, random access, and text and data services

Specific points relating to the Committee's Terms of Reference:

 The scope and role of Australian community broadcasting across radio, television, the Internet and other broadcasting technologies

We believe that it is important to enable Australian community broadcasting to maintain relevancy in the evolving context of technologies; competition for audiences will continue to increase but we believe that locally produced radio programs will continue to be both desirable and needed even if new hybrid forms of programs may be developed. Community radio also plays an important role in distribution of governments messages (eg GST, industrial relation etc) in targeting specific languages.

The community broadcasting sector is a significant part of the media landscape, providing the community with a diverse and independent platform for expressing views and ideas, offering a range of cultural and community services that commercial and public services are not expected to provide.

 Content and programming requirements that reflect the character of Australia and its cultural diversity

Australia has evolved an enviable and internationally unique system of community media, particularly in community radio; a system which is responsive to the needs of our culturally diverse community. There are, however, still unmet demands, particularly for recent (emerging) and small communities. As well, in some larger language communities the existing broadcast times may not enable program makers to cater equitably for the diversity found within that community (eg, age; gender; religious; cultural/linguistic needs)

Technological opportunities, including digital, to expand community broadcasting networks; and

While there may be many opportunities to expand community broadcasting networks, a very important principle must be preserved: the closeness between program makers and their audiences. Ultimately INDIVIDUAL listeners must find that they are being addressed. Technologies may improve the quality of the signal and distribution, but closeness to target communities remains the overriding issue.

Opportunities and threats to achieving a diverse and robust network of community broadcasters.

We believe that Australia's network of community broadcasters at present is based on a suitable mix of technological experimentation and innovation; government encouragement; sponsorship; and, voluntary effort. However, as sweeping changes are about to impact on the sector there will be a need to enable the migration to and use of new technologies. This will require a clear policy by Governments – both on the introduction of new technologies and on how to continue support the robust participation by the broad range of community interests.

In particular, we believe that Australian ethnic community broadcasting needs to be supported not only technologically, and through some support for all groups to get to air with important community information in a wide range of languages, but also through continuing training programs.
