## SUBMISSION ON SUSTAINABILITY CHARTER

I would like to congratulate the Committee both on the Sustainable Cities report and on this important Inquiry. Commonwealth Government commitment to sustainability and to institutions to enable the development of more sustainable government policies – at all levels – is very much needed in Australia. Since the Ecologically Sustainable Development process in the early 1990s, little has been done to embed sustainability in the workings of the Commonwealth Government. It is encouraging to see the development of this inquiry and I hope that it will be the beginning of the implementation of many policies and initiatives for sustainability.

My doctoral research focused on the context for, development and use of *Australia: State of the environment 1996* with a comparative case study of the equivalent report for England and Wales prepared in 1996. This research is highly relevant to this inquiry as it looked at how information could inform policy making with regard to sustainability.

Attached to this submission, please find:

- an extract from my PhD thesis 'Asking awkward questions about environmental information: State of the environment reporting in Australia and England and Wales'.
- a draft paper for the Journal of Environmental Policy and Planning. Please note that this paper has not yet been submitted and is not to be quoted without permission.

I would also recommend that consideration be given the references (see list attached), in particular:

These references provide a large number of suggestions and recommendations relevant to this inquiry.

On reading the discussion paper, I'd make the following additional comments

- The establishment of a Sustainability Commission and Charter is supported.
- Targets are only useful if linked to regulation or funded policies and programs.
- Undue attention should not be given to the development of indicators at the expense of more comprehensive ways of evaluating policy impacts (see, in particular, the literature on 'realistic evaluation' (Eg. Pawson and Tilley's (1997) book 'Realistic Evaluation').
- The process to develop a Sustainability Charter and Commissioner should learn from the experience of the last decade of state of the environment reporting in Australia (and internationally).
- The charter should 'join up' and fund levels of government (as discussed on page 12 of the discussion paper).

On the basis of my research and professional experience, it is recommended that:

- The Sustainability Commission be given statutory independence and sufficient ongoing funding to conduct its work.
- The Committee look to models of the Royal Commission on Environmental Pollution (RCEP) and the New Zealand Parliamentary Commissioner for the Environment as successful models of statutorily independent institutions which have been able to successfully influence government policy making with regard to sustainability.
- The Commission's mandate must include social, economic and environmental sustainability and public participation.
- The Committee consider establishing a Commission with several Commissioners rather than a single individual in order for the Commission to draw on the experience and wisdom of several experts in the form of an expert panel rather than a panel of experts as is the case with the Royal Commission on Environmental Pollution see Owens, S., & Rayner, T. (1999). When knowledge matters: The role and influence of the Royal Commission on Environmental Pollution. *Journal of Environmental Policy and Planning, 1*(1), 7–24.
- The development of indicators should not be a major focus on the Commissions work (if it is included at all). Considerable resources have already been expended to develop indicators as part of national state of the environment reporting and it is my contention that the focus on indicators has distracted attention away from the vital task of implementing and evaluating (in a more holistic manner) policies for sustainability.
- The Commission should instead undertake inquiries into specific topics eg. into sustainable transport in Australia; the regulation of sustainable housing; social and community housing.

I would welcome the opportunity to provide further input for the Committee to assist its work on Sustainability.
