

The Natural Step offers a framework that is based on science and serves as a compass for society and individuals working to redesign their activities to become more sustainable. The Natural Step Framework is based on systems thinking, focusing on first-order principles. Four Systems Conditions provide a practical framework which can be used to guide social, environmental, and economic actions.

In the sustainable society, nature is not subject to systematically increasing...

- 1. ...concentrations of substances extracted from the Earth's crust;
- 2. ...concentrations of substances produced by society;
- 3. ...degradation by physical means; and, in that society. .
- 4. ...human needs are met worldwide.
