Public hearings in Queensland 22-24 November 2006

Regional tourism employment to feature

Employment by regional tourism operators will be the focus of public hearings to be held in Queensland by the House of Representatives Employment Committee on 22 - 24 November 2006 as part of its inquiry into the workforce challenges facing the Australian tourism sector.

The Committee will hear from a range of groups including small and large employers, training organisations and representatives from the tourism industry.

Widespread labour and skills shortages have the potential to jeopardise Australia as a destination for international tourists. However, tourism has the potential to make a significant contribution to regional economies so solutions must be found to the recruitment and retention challenges facing the industry.

While in Cairns, the Committee will also be visiting Tjapukai Aboriginal Culture Park to hear about indigenous employment initiatives and the International Marine Centre of Excellence to assess innovations in training.

"The tourism industry faces particular challenges with some skill shortages, at times more isolated work locations, and often a transient and seasonal workforce. Even though tropical north Queensland is a favourite destination for tourists, local businesses are having difficulties recruiting staff," Committee Chair, Phil Barresi said. "The inquiry is examining how best to support continued employment growth in the industry and ensure Australia stays on the tourist map."

"The Committee is also looking for examples of innovative practices of the industry to attract a workforce that will stay in, and grow with, the sector."
