At The Present Time The Allocated Funding Does Not Cover For 24Hr Care And I Have To Provide 21 Day Hrs Per Week And Also 4 Weeks Per Year That Is Expected To Be Made Available Through Respite Care But As There Is An Acute Shortage Of Respite Beds I Have Not been Able To Place My Son So The Responsibility Rest With Me To Cover The Shortfall.

Also There Is A Very Real Need For Carer Support Across The Country And At Present We Can Not Get The Coverage Required. I Am Presently Supplying 4 Extra Night Sleepovers From 4.30.pm Till 9.00.am That Has Been Ongoing For The Last Few Months.

Baptist Care Are Advertising For More Support Staff And I Hope That My Position May Improve In The Very Near Future.

As I Am Nearing My 60s And My Husband His 70s I Am Concerned What The Future Will Hold For My son And Our Family Structure As The Time Spent Caring Will Eventually Take Some Toll On All Parties.
