Nuclear transfer and safeguards agreements with China

Review of a nuclear material transfer and a nuclear material safeguards agreement with China

The Joint Standing Committee on Treaties, chaired by Andrew Southcott MP, will hold a public hearing on Monday 4 September to examine two agreements between the Governments of Australia and China relating to the transfer and safeguard of nuclear material.

With an estimated 36 per cent of the world's low-cost recoverable uranium deposits, Australia is well-placed to expand its uranium exports and meet China's long-term uranium demand which is expected to quadruple by 2020.

The nuclear material transfer agreement would allow for the supply of Australian uranium to China's nuclear power program. The nuclear material safeguards agreement would provide for cooperation on various nuclear issues; including the transfer of nuclear-related material, equipment or technology. Together, the Agreements have the same effect as provisions contained in Australian safeguards agreements.

"The Committee will examine the benefits and determine whether the Agreements are in Australia's national interest," Dr Southcott said.

In addition, the Committee will receive further evidence on two treaties: Mutual Assistance in Criminal Matters and an Exchange of Notes; and Extradition and an Exchange of Notes with the Government of Malaysia.

The public hearing will be held in **Committee Room 2R1**, **Parliament House**, **Canberra** on **Monday**, **4 September 2006** from **10.00 am**.
