THE TAX COMMISSIONER DOES NOT HAVE AN OFFICE, HE CANNOT APPOINT ANY DEPUTIES TO RUN THE TAX OFFICE BECAUSE IT IS NOT A LEGAL ENTITY. THE AUSTRALIAN TAX OFFICE CANNOT APPEAR AS A PARTY IN THE HIGH COURT AS IS NOT AN ENTITY. TAXATION IS A COMPELLED BENEFIT AND AS SUCH IS UNENFORCEABLE UNDER LAW. THE PRESENT SYSTEM OF TAXATION.
