## **Lombok Treaty Public Hearing**

The Treaties Committee will hear further evidence on the Lombok Treaty at a public hearing on Monday 26 March 2007. The Committee will hear from the director of the Strategic and Defence Studies Centre at the Australian National University, Professor Hugh White, who has written a recent article expressing his scepticism on the value of the Agreement.

The Committee will also hear from the Australian Council for International Development, whose submission expresses concern that non-profit agencies might be disadvantaged as a result of misinterpretation of three key terms in the Agreement, as well as the Human Rights Law Resources Centre and ELSHAM, the Institute for Human Rights Study and Advocacy, Papua.
