## Committee roundtable to discuss constitutional reform

Constitutional reform is the focus of a roundtable discussion to be held by the House of Representatives' Legal and Constitutional Affairs Committee on Thursday 1 May at Parliament House, Canberra. Federal-State relations, a constitutional preamble and issues of citizenship will be among the topics discussed.

Committee Chair Mark Dreyfus QC said "The roundtable discussion will explore the current debates surrounding constitutional reform, and assist the Committee in identifying areas in which we can affect some change in the near future The governance group at the 2020 summit produced some good preliminary ideas, and the Committee hopes to build on some of these ideas through the roundtable ".

Issues to be discussed on the day include:

- the process for amending the constitution;
- election terms and qualifications of parliamentarians;
- federal-state relations in relation to constitutional powers; and
- the inclusion of a constitutional preamble.
