Fringe benefits tax encouraging the use of FIFO?

On Wednesday, the Regional Australia Committee will be hearing evidence from the Australian Taxation Office (ATO) and Treasury regarding taxation policy and administration as well as the impact that these policies are having on the use of fly-in, fly-out (FIFO) and drive-in, drive-out (DIDO) workforce practices. The Committee will also hear from the Hon Bruce Scott MP, the member for Maranoa, as well as remoteFOCUS.

Throughout the inquiry, the Committee has received evidence regarding fringe benefits tax (FBT), the living away from home allowance and the zone allowance and the impact that these policies are having on FIFO/DIDO workforce practices. It has been suggested that these taxation policies, especially the introduction of the FBT in 1986, have been significant factors in the increasing use of FIFO/DIDO workforce arrangements.

The Chair, Mr Tony Windsor MP, said, 'it is essential that the Committee gains a comprehensive understanding of these taxation policies and their impact on FIFO/DIDO. We want to ensure that Australians living in regional and remote communities are assisted, not disadvantaged, by taxation policy.'
