PARLIAMENTARY STANDING COMMITTEE ON PUBLIC WORKS

FIFTY-FOURTH GENERAL REPORT


Pursuant to section 16 of the Public Works Committee Act 1969, the Parliamentary Standing Committee on Public Works is required to report to Parliament annually on its proceedings during the previous 12 months. This report, the Committee's Fifty-fourth General Report, is for the period 1 January 1990 to 31 December 1990. The report period covers the proceedings of the twenty-ninth and thirtieth committees.

About the Committee

- The Committee was established in 1913. It is one of the oldest investigative committees of the Parliament. The Committee is constituted by the Public Works Committee Act which gives it wide-ranging investigative powers.
- All Commonwealth public works estimated to cost more than \$6 million are subject to referral to the Committee by either House of the Parliament or by the Governor-General. There are some exceptions to this rule, but essentially all public works sponsored by Commonwealth departments or agencies with large building programs come within the ambit of the Committee's investigatory power.
- Design and construction authorities are able to plan the design and location of a proposed public work and receive a commitment from the Parliament for the provision of funds to carry it out. Work on a project can only start after the Committee has presented its report to Parliament and after the Parliament - the House of Representatives - has resolved that the public work should proceed.
- The Committee conducts public hearings into all proposals referred to it. At these hearings members of the Committee question witnesses representing the sponsoring department and the design and construction authority to establish:
 - if there is a need for the proposed work;
 - if the proposed work will adequately satisfy the need;

- if the estimated cost can be justified; and
- . the amount of revenue, if any, to the Commonwealth.
- 5. All large projects examined by the Committee have financial, social and environmental impacts on local areas and on the community at large. For this reason the Committee requires that sponsoring departments and agencies to consult local groups, organisations and authorities, unions and environmental groups during the development of a proposal. When a proposal is referred to the Committee, these bodies are encouraged to make submissions and for office-bearers to appear as witnesses. Matters raised in submissions and by witnesses are taken up with departmental officials at the public hearing. Matters which need to be further addressed during detailed design may, if necessary, be highlighted in the form of recommendations in the Committee's report to Parliament. The Government's response to these recommendations is given when the House of Representatives debates the expediency motion which, when passed, constitutes parliamentary approval for a proposed work. In most instances the Government accepts the Committee's recommendations.

Membership

30th Committee





13. In February 1990 the Committee undertook site inspections and public hearings into five references. The House of Representatives was dissolved on 19 February 1990 and all references lapsed. It should be noted that the Committee had assembled the bulk of evidence which would enable the incoming 30th Committee to present reports as soon as possible after the proposals had been referred to it.

References and Reports - 30th Committee

- 14. The 36th Parliament was opened on 8 May 1990. As mentioned above, members of the Committee were appointed by the House of Representatives and the Senate on 10 and 14 May respectively. On 14 May the House of Representatives re-referred to the Committee for consideration and report five proposals into which the 29th Committee had previously inquired but which had lapsed. The Committee moved very quickly in finalising reports on these references; the reports were presented on 16 May. A further lapsed reference, on which the 29th Committee was unable to commence its inquiry, was re-referred to the Committee on 1 June 1990. Thus, by the end of the Autumn Sittings of Parliament the Committee had reported on all references which had lapsed with the dissolution of the House of Representatives.
- 15. During the balance of the year the Committee received ten new references and presented reports relating to five of them. At the end of 1990, there remained five unreported references for which inspections and hearings were held in late December 1990 or were scheduled to take place early in 1991. The unreported references were:
 - Redevelopment of Borneo Barracks, Cabarlah, Queensland referred on 6 November 1990;
 - . Construction of major explosives storehouses, Stage 1, at Myambat, NSW referred on 20 December 1990;
 - Redevelopment of the Singleton Military Area, Stage 1, NSW referred 20 December 1990;
 - Purpose built computer centre for Australian Customs Service, Bruce, ACT - referred 20 December 1990; and,
 - Construction of an Australian Embassy complex at Jakarta, Indonesia - referred 21 December 1990.
- 16. A table listing reports presented by the Committee during the report period is at APPENDIX A.
- 17. The estimated cost of proposals reported on by the Committee during 1990 was \$559 million.

Non-referral of Defence Works

- 18. No works were exempted from the Committee's scrutiny granted under section 18(8)(c) of the Public Works Committee Act. This section provides that the Governor-General may exempt a proposal for defence purposes on the grounds that reference to the Committee would be contrary to the public interest.
- 19. The Committee was, however, advised of a variation to a project which had been previously exempted: Defence Signals Directorate (DSD) and HOADF/Command and Control Facilities. Canberra.
- 20. The Committee, whilst noting the variation, took the opportunity to request more information in the future about proposals exempted on security grounds. The Committee suggested to the Department of Defence that information such as the general nature and purposes of such facilities, size, location, estimated cost and likely environmental impacts could be made available to it on a confidential basis without disclosing matters of a security nature. It was suggested that in some cases it may be appropriate for the Committee to be briefed by officers of the department.
- 21. In response, the department undertook to provide the Committee with more information; the Committee could then decide if it required a briefing.

Urgent Works

- 22. On 15 May 1990 the House of Representatives agreed to exempt the proposed construction of the Australian Pavilion at Expo 92 in Seville, Spain from Committee scrutiny on the grounds of urgency. This motion was made under the provisions of section 18(8)(b) of the Public Works Committee Act, which provides that -
 - (8) A public work the estimated cost of which exceeds six million dollars shall not be commenced unless -
 - (b) the House of Representatives has resolved that, by reason of the urgent nature of the work, it is expedient that it be carried out without having been referred to the Committee:

- 23. During debate on the motion, the Minister representing the Minister for Administrative Services advised the House of the background for the need to exempt the proposal on the grounds of urgency. Factors which compounded the urgency were:
 - uncertainty amongst pertinent agencies responsible for planning the proposed work about the applicability of the Public Works Committee Act to this proposal;
 - the applicability of the provisions of the Public Works Committee Act to this proposal was confirmed by the Attorney-General's Department in early April 1990;
 - . the exposition is scheduled to open in April 1992;
 - construction of the pavilion must be completed by September 1991 to allow time for exhibits to be in place and for the staff of the pavilion to be fully trained;
 - the construction timetable envisaged the award of a piling contract in mid-April 1990 with the award of a contract for the pavilion works in June 1990; and,
 - each month of delay in committal would add at least \$1.0 million to construction costs as well as greatly increasing the risk of the project not being completed on time.
- 24. Officials from Australian Construction Services and the Department of Arts, Sport, Tourism, the Environment, Tourism and Territories briefed the Committee on the need for urgency.
- 25. Following the exemption of the work, the Committee advised the Minister for Administrative Services that:
 - the Committee was concerned that circumstances had arisen which prevented the proposal being subject to Parliamentary (i.e. Committee) scrutiny;

- the Committee therefore sought an assurance that in future situations where doubt exists regarding the applicability of the Act, the Committee be consulted at the earliest opportunity so that possible Parliamentary action is not precluded;
- the Committee requested to be kept informed of the progress of the project.
- The Minister gave the Committee the assurances sought.
- 27. The Committee now receives quarterly reports from Australian Construction Services covering physical progress and expenditure on the Expo 92 building and fitout works. Two such reports have been received by the Committee.


Overseas Works

- 28. During the report period, the Committee examined the proposed construction of the Australian High Commission and Defence Housing in Port Moresby, Papua New Guinea. Similar embassy-type proposals have been examined by previous Committees.
- 29. The Committee is concerned that it is precluded by the Public Works Committee Act from travelling overseas to inspect locations and sites of proposed facilities and to have informal discussions with local staff and authorities. Instead, very often local embassy staff and design and construction personnel are required to travel to Canberra to appear at the Committee's public hearings. The Committee suggests that it may be more cost-effective for it to be permitted to travel to countries where new embassy or high commission projects are proposed. Adequate local knowledge is important to the Committee, and very often this cannot be simply gleaned from video productions and written submissions. Accordingly, the Committee has written to the Minister for Administrative Services requesting that the Act be amended.

Progress of Proposals Previously Referred

30. During the report period the Committee inspected a number of projects on which it has reported which had been completed or on which construction had commenced. The Committee intends continuing this practice of inspections.


- 31. Projects inspected were:
 - Armoured Centre, Puckapunyal (8/81*);
 - Brisbane Airport Domestic Terminal and Control Tower (7/82);
 - . RAAF Base East Sale (13/82); and,
 - . New Commonwealth Offices at Oakleigh, Vic (12/88).
 - (* year and number of the Committee's reports on the proposals)
- 32. Members of the Committee on private overseas visits usually take the opportunity to inspect construction work on overseas embassy projects. In this regard the Chairman and Senator Calvert inspected construction of the Australian embassy in Tokyo, while Mr B. Scott MP inspected work on the Australian embassy in Beijing. However, this is not a satisfactory arrangement given the situation described in paragraph 29.

Energy Targets and Energy Audits

- 33. During the year the Committee continued to focus some attention to the energy efficiency of building proposals referred to it. The Committee has requested that sponsoring departments and design and construction authorities set achievable energy targets, and thereby not design buildings requiring unusually large and unjustifiable amounts of energy for lighting and climate control.
- 34. A briefing on energy targets and energy audits was presented to the Committee by senior engineering staff of Australian Construction Services. Further briefings are planned, dealing with Sick Building Syndrome and Legionnaires' Disease. The Committee believes this program of thematic briefings will enhance its understanding of contemporary issues, research and design solutions relevant to the built environment.

Child Care Facilities

- During the report period the Committee continued to focus attention on the provision of child care facilities in or adjacent to new buildings, especially office blocks.
- 36. In the case of the Dedicated Computer Centre for the Australian Taxation Office (ATO) at Bruce, ACT, the ATO argued that it would not be cost-effective to include a child care centre within the facility. The provision of a centre would have capital and recurrent cost implications. A heavy financial burden would be placed on any users of a facility because current government guidelines provide that Commonwealth agencies are not to provide any recurrent subsidy towards the operation of child care services. The close proximity to the proposed computer centre of several child care and pre-school facilities would provide an adequate alternative to an in-house facility.
- 37. In the case of the refurbishment of the Reserve Bank of Australia (RBA), Martin Place, Sydney, a child care facility was not included. The RBA officials advised the Committee that to the best of their knowledge, there are no child care centres within the Sydney CBD. The RBA is nevertheless monitoring child care practices in other banks, Commonwealth departments and statutory authorities. The RBA reviewed options for providing child care assistance to staff in 1989; it decided no action was appropriate at the time because the bank was not out of step with relevant areas of employment elsewhere. The Committee was advised, nevertheless, the RBA would review options for the provision of child care facilities in 1991 as part of the bank's equal opportunity program.
- 38. It was suggested to the RBA by the Committee that the bank, in concert with other banks located in the Sydney CBD could, by using collective resources, lead the way in providing a single child care facility for the employees of all banks within the CBD. The RBA undertook to investigate this concept.
- 39. The foregoing demonstrates three matters which should be adhered to by departments or agencies planning proposals with potential requirements for child care facilities. First, when planning a proposal, planners should explore all available avenues for the provision of child care facilities. Secondly, alternative arrangements should be identified and their implications assessed against established criteria. Thirdly, the reasons why a particular course of action is proposed should be documented and stated

in submissions to the Committee. These three steps will, of necessity, require planners to consult with staff organisations before and during their implementation.

Public Works Committees

40. In September 1990 the Committee was visited by members and staff of the Queensland Parliamentary Committee of Public Works. During the visit members of both committees exchanged views on operational, procedural and technical matters relevant to the conduct of inquiries. Similar exchanges of views took place during a visit from the Chairman and Secretary of the South Australian Public Works Standing Committee. The Committee sees great benefit in continuing to foster these exchanges of ideas and information with State Public Works Committees.

Seminars

- 41. The Chairman addressed a seminar for new Members of Parliament in April 1990. In September 1990, the Chairman, accompanied by the Vice-Chairman, addressed a seminar arranged by the Parliamentary Education Office, for Masters candidates enrolled at the Australian Defence Force Academy. The theme of the seminar was Parliamentary Scrutiny of Public Projects' and the Chairman spoke about the role of the Public Works Committee in the scrutiny process. The Committee receives frequent requests for information from post-graduate students examining the public scrutiny process.
- 42. In November 1990 the Chairman addressed officers of the Overseas Property Group about the activities of the Committee.

Member of the Order of Australia (AM)

43. The Committee notes with pleasure that its former Vice-Chairman, Clarrie Millar, was created a Member in the General Division of the Order of Australia (AM) on Australia Day 1991. This award was made for services to the Parliament.

Vale

44. The Committee was saddened to learn of the death of a former Secretary, R. B. Fenton, in January 1990. Dick Fenton was Secretary to the Committee from October 1972 until his retirement in July 1986. During this period he was involved in more than 150 inquiries, and attended the Committee at public hearings and private meetings on more than 500 occasions. He served five Chairmen and eight Committees. At the time of his death he was working on a history of the Public Works Committee.

Appreciation

45. The Committee gratefully acknowledges the assistance of many organisations and individuals who assisted with various facets of public hearings and inspections. The Committee also extends its appreciation to the Parliamentary Reporting Staff, the staff at the Government Printing Office, the office of the Minister for Defence, the House of Representatives Printing Section, the Resource Management Office and the House of Representatives Transport Office.
