Inquiry into regional aviation in Australia

Qld & northern NSW witnesses at public hearings in Brisbane Wednesday 11 June & Thursday 12 June 2003

The House of Representatives Transport and Regional Services Committee is examining the adequacy of regional aviation services and transport links to Australia's major populated islands.

The committee will hold the 10th and 11th public hearings of its inquiry in **Brisbane** next week, to gather evidence from Queensland and northern NSW regional councils, small airline operators, airport owners and government.

Appearing will be representatives from **Bundaberg**, **Rockhampton**, **Mackay**, **Tamworth**, **Toowoomba** and the **Fraser Coast** (Maryborough).

Also appearing will be CEO of Aviation Australia, Mr Paul Bredereck. Aviation Australia is a new training organisation established by the Queensland Government to support the development and growth of the aviation and aerospace industries in Queensland and in the Asia Pacific region. Aviation Australia has been set up with the support of Australia's major airlines and aerospace companies as well as Queensland's leading universities. Mr Bredereck was also the owner of the former airline, Tamair.

In his submission (Submission number 42 on the inquiry website, see link below) Mr Bredereck suggests a community based national organisation be created to assist in providing air services on marginal routes. He says State Governments have no place in licensing air routes or operators.

In contrast, Mr Ranald McFarlane, Managing Director of Macair Airlines (Submission number 76 on the inquiry website) believes State Governments do have a role in protecting routes. Both Mr Bredereck and McFarlane say the Civil Aviation Safety Authority impose significant costs on smaller regional airlines.

House Transport Committee Chair, Mr Paul Neville MP, says the inquiry has received more than 170 submissions from interested organisations and individuals.

"The evidence shows that while larger centres are well served by the current aviation arrangements, regional and remote Australia is not. Key issues are costs and returns, service levels, interconnectivity between services, the maintenance of country airports, regulation and coordination," Mr Neville said.
