## Inquiry into integration of regional rail and road networks with ports

The House of Representatives Transport and Regional Services Committee is conducting an inquiry into the integration of regional road and rail networks and their interface with the ports.

The committee will hold the next public hearing for the inquiry in Melbourne on Monday, 25 July 2005. Further hearings will be held in Portland on Tuesday 26 July 2005 and Melbourne again on Wednesday 27 July 2005.

The Chair of the Committee, Paul Neville, said the inquiry is examining the operation of regional road and rail arterial networks in handling the rapidly growing task of moving Australia's freight. An important part of this inquiry will be a consideration of the way those networks connect with the ports.

Mr Neville said that the Committee would be looking for ways in which greater efficiency can be achieved in the freight transport task, and how the three levels of government can co-operate to achieve this outcome.

"This is a large inquiry," Mr Neville said. "There has been strong interest in the inquiry and over 100 submissions have been received so far. Further public hearings will be conducted at important transport centres around Australia. The Committee expects to table its report early next year."
