8. Can you tell us about any times that legal aid workers were unable to spend enough time with your organisation's members or clients?

9. How have your organisation's members or clients obtained legal aid—in person or by phone or some other way?

10. Can you tell us about any times your organisation's members or clients were particularly satisfied with the legal aid they received?

11. Can you tell us about any times your organisation's members or clients were not satisfied with the legal aid they received?

12. Can you tell us about any difficulties Indigenous women have in getting legal aid?

13. Can you tell us how the legal aid needs of Indigenous men and women are different?

14. Can you tell us whether your members or clients prefer dealing with an Indigenous legal aid service rather than a mainstream legal aid service?

15. Can you tell us about any cooperative programs or agreements between your organisation and your local legal aid service?

16. What suggestions could you make to improve the legal aid services available to Indigenous Australians?

17. Are there any other issues relating to legal aid for Indigenous Australians that you would like to mention? Please attach extra pages if you need more space. We will read whatever you send us.
