Questions taken on notice by DIMA from Committee Hearing on 30 January 2001

AUSTRALIA'S COOPERATIVE ARRANGEMENTS ON ILLEGAL MIGRATION

In response to the significant increase in recent years in the unlawful movement to Australia of people from countries in the Middle East and South Asia, many of whom are refugees with protection needs, Australia has developed an integrated and comprehensive strategy which is comprised of three essential elements:

- (i) Taking bilateral and international action to minimise primary outflows from countries of origin and secondary outflows from countries of first asylum a strategy of *prevention*.
- Through programs to support sustainable repatriation, local integration where repatriation is not achievable, or resettlement where neither repatriation nor local integration is achievable.
- Through providing direct support to aid programs in countries of origin for refugees and countries of first asylum.
- Through targeted information campaigns to highlight the futility of attempting illegal entry to another country and the dangers of using people smugglers.
- (ii) Working with other countries to *disrupt* the activities of people smugglers (including their prosecution).
- Through sharing information on routes and methods used by people smugglers and working cooperatively to intercept and detect unauthorised arrivals (eg through the placement of Airport Liaison Officers at key overseas airports).
- Through technical cooperation in border control and law enforcement areas.
- (iii) Developing appropriate *reception* arrangements for unauthorised arrivals who reach Australia, focusing on the early assessment of their claims for refugee status and the prompt removal of failed asylum seekers or those who can be given effective protection elsewhere.
- Through the introduction of the temporary protection visa arrangements to reduce incentives to bypass resettlement programs overseas or to fail to seek protection in other countries in which they have resided and where effective protection could have been provided.
- Through seeking to establish an interlocking web of agreements between countries that provide for the return and readmission of those seeking to circumvent the international protection system by illegal entry to a destination country.

International cooperation

The strategy outlined above depends on the development of strong and constructive relationships with a range of countries, particularly first asylum and transit countries. Accordingly, a broad diplomatic campaign aimed at increasing cooperation on people smuggling and irregular immigration issues has been initiated, involving Ministers and officials. DIMA has sought to negotiate bilateral arrangements with a range of transit and first asylum countries to implement the various elements of the government's strategy. The progress in these negotiations to date is summarised below.

East Timor

- Australia has commenced discussions with the United Nations Transitional Administration in East Timor (UNTAET) and the East Timor Transitional Administration on the possible development of interception arrangements to deter people smugglers from targeting East Timor as a transit point to Australia.
 - UNTAET has already assisted with the interception of a small number of people seeking to transit East Timor and the International Organisation for Migration (IOM) have facilitated their return to their country of origin.

Indonesia

- Australia and Indonesia have implemented a series of arrangements which are intended to disrupt people smuggling routes through Indonesia and to provide for the protection needs of Australia-bound third country nationals. These arrangements have come to be referred to by both sides as the Regional Cooperation Model (RCM), although no formal agreement has so far been concluded. The arrangements continue because there is an acceptance of mutual benefit in cooperation.
 - Under the RCM, Indonesian authorities intercept and detain irregular migrants in Indonesia.
 - They notify the IOM, who provides practical support and assists the Indonesia authorities with voluntary returns.
 - Where protection concerns are raised, the person is referred to the UNHCR for assessment and identification of an appropriate durable solution.
- A draft Memorandum of Understanding with the Indonesian Government to formalise these arrangements is on the table. Agreements between Australia and the IOM are already in place and arrangements between Australia and the UNHCR are being finalised.
- Australia and Indonesia are cooperating on law enforcement activities designed to disrupt people smuggling operations in that country, including training for Indonesians to assist them to detect document fraud.

Iran

- Following discussions between Australia and Iran, Australia has proposed that a framework for cooperation on refugees, irregular migration and people smuggling be established between the two countries.
 - A draft framework has been developed that covers a range of issues, including technical cooperation, cooperation in international fora, the return of Iranian nationals, the readmission of third country nationals and the provision of aid to Afghanistan.
 - Discussions on the draft framework are continuing.

Jordan

• Following visits by the Minister, Mr Ruddock, to Jordan in January 2000 and January 2001, we have established effective information exchange arrangements and agreed arrangements for the management of the transit of Iraqis returning to Iraq from Australia.

Pakistan

- Discussions between Australia and Pakistan have resulted in the development of a draft framework for cooperation on refugees, irregular migration and people smuggling, which is currently under consideration by both countries.
 - The draft framework covers arrangements for technical cooperation, a jointly developed information campaign, the provision of aid to Afghanistan and to refugees in Pakistan, the return of Pakistani nationals, transit arrangements for Afghans returning to Afghanistan and readmission arrangements for third country nationals.

Papua New Guinea (PNG)

- Australia and PNG have an MOU in place that provides for the readmission of third country nationals where there are no protection needs to be taken into account.
- Australia and PNG are also exploring further opportunities to cooperate on initiatives to combat people smuggling and irregular migration.

People's Republic of China (PRC)

- Australia and the PRC agreed in April 1996 streamlined arrangements for the return of PRC nationals who arrive in Australia by boat. These arrangements are premised on an undertaking by Australia to take back any returned boat person subsequently determined not to be a PRC national. These arrangements have been operating effectively since 1996 and have provided a significant contribution to reducing the number of PRC nationals arriving by boat in Australia over recent years.
- Australia also has a safe-third country agreement with the PRC in respect of the Sino-Vietnamese resettled in China who have arrived in Australia illegally. These arrangements recognise the principle that these people have effective prior protection in the PRC.

Syria

- Progress in developing cooperation between Australia and Syria in relation to irregular migration and people smuggling was achieved through a meeting between the Secretary, DIMA, and the Syrian Director of Immigration and Passports Department in Damascus in January 2001.
- Australia and Syria have agreed to a range of technical cooperation and information exchange initiatives aimed at combating people smuggling.
- Both countries have also agreed to accept returnees from the other country if they are the citizens of either country or have equal status.

Turkey

- Australia and Turkey have discussed establishing an agreement between the two countries designed to assist combat irregular migration and people smuggling. Turkey at that time provided a much wider draft bilateral law enforcement agreement for Australia's consideration. This agreement is being examined by the relevant portfolios, including the Attorney-General's and Immigration and Multicultural Affairs.
- Discussions with Turkey have also focused on the arrangements for the management of Iraqis transiting Turkey to the northern areas of Iraq. These discussions are continuing.

PROSECUTION OF PEOPLE SMUGGLERS

The Committee requested details of the penalties being given by the courts to persons convicted of bringing unlawful non-citizens to Australia. Attached at A are details of the prosecutions in the Northern Territory and Western Australia.

The Committee expressed concern that these persons did not benefit from their period of imprisonment by taking home monies earned in the prison system or goods brought while in prison.

There are provisions in the Migration Act that permit the Department to recover the costs of immigration detention and removal of unlawful non-citizens. Indonesian nationals serving sentences for fisheries or people smuggling offences are paid gratuities to provide for daily necessities, ie cigarettes, sweets and other items not generally provided by the prison system. Prisoners do accumulate the gratuities and purchase items such as television sets and video cassette recorders.

The Migration Act enables the Department to seize valuables to cover a debt to the Commonwealth for the costs of detention and removal. Valuables are defined as articles of worth or value, valuable goods or possessions and this includes electronic goods such as televisions. The money and valuables of unlawful non-citizens are seized when they are removed. However, the Department does leave the removees with some cash to ensure that they can travel to their home villages from the airport.

DEATH BY DROWNING OF PERSONS WHO ATTEMPTED TO ARRIVE IN AUSTRALIA WITHOUT AUTHORISATION BY BOAT

The known incidents that have occurred in respect of arrivals in Australia are:

Vessel codenamed 'Paroo' 24 December 1998 - one person drowned when 53 PRC nationals tried to swim ashore after their boat hit a reef near Cobourg Peninsula in the Northern Territory.

Vessel codenamed 'Augustus' 20 July 1999 - 15 persons drowned when their boat sank near Christmas Island. Twenty passengers were left to steer the vessel to Christmas Island. The vessel's engine stopped and it started to take on water. The vessel drifted away from Christmas Island and sank 40 nautical miles from Christmas Island.

Vessel codenamed 'Xmas' 15 December 1999 - one person drowned when the vessel overturned near Cockatoo Island, Western Australia.

Vessel codenamed 'Rosalie' 21 December 2000 – three persons drowned whilst attempting to cross from Lagrange Island, in remote northwest Western Australia, to a nearby island on a raft made from drums to search for fresh water. The people on this vessel originally departed Kupang, Indonesia, on a boat with 63 passengers. A group of 39 passengers demanded to be returned to land when the seas became rough. The vessel codenamed 'Rosalie' left from Alor about 15 days later with the remaining 34 passengers on board.

In addition to this there have been a significant number of incidents when lives have been placed in danger and would have been lost but for the assistance of Royal Australian Navy and Australia Customs Service vessels on civil surveillance patrols and rescue and emergency workers in remote locations.

In relation to drownings that may have occurred on the high seas or in Indonesian waters, there have been a number of reports of this nature but there is no confirmed or publicly available information on this. It would be reasonable to assume however that lives have been lost. It is known that a number of boats have been wrecked or damaged in Indonesian waters through collisions with reefs etc.

FELONIES THAT MAY HAVE OCCURRED ON BOARD VESSELS

There has been one instance of a possible felony connected with the arrival of the vessel codenamed Adelong with 353 persons on board in November 1999. Three items of luggage on a vessel were initially unclaimed. It was alleged that two women were murdered and their bodies thrown overboard. This allegation was immediately referred to the Australian Federal Police who investigated the matter with the Western Australian Police Service. A number of people from the vessel were interviewed. All the luggage was accounted for. It was found that there was no substance to the matter.

There have been no other reports of felonies associated with unauthorised boat arrivals.
