Request for Information on Computer Related Security Breaches

I refer to your request of 16 September 2003 for details of any breaches of computer security that have occurred in the Department of Employment and Workplace Relations and its associated agencies since July 1998.

Stolen equipment is reported by the Department to the Australian Federal Police for investigation. Records are readily available only for the last two financial years: 2001/2002 and 2002/2003.

Breaches of computer security are treated by the Department in accordance with the Defence Signals Directorate Information Security Incident Detection, Reporting and Analysis Scheme (ISIDRAS).

The Department is not aware of any other significant events involving information technology security.

As requested, information from the portfolio agencies has been included.

This response is based on information currently available, but is subject to revision as further information becomes available through investigations by the agencies concerned.
