DEAR SIRs.


IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY BE RATIFIED. WE WELCOME CLOSE TIES WITH THE INTERNATIONAL COMMUNITY ON LAW. THE EXECUTIVE AS STATED IN A RECENT INQUIRY TO THE SENATE ON OUR LEGAL SYSTEM, WE BELIEVE THAT IT IS NOT THE AMOUNT OF LAW THAT IS THE PROBLEM WITH OUR LEGAL SYSTEM BUT IT IS THE AMOUNT OF DIFFERENT TYPES OF LAW IN AUSTRALIA. WE WOULD LIKE TO SEE ALL LAW IN AUSTRALIA PLACED UNDER FEDERAL LAW, ABOLISH ALL CROWN LAW, ALL STATE LAW, ALL ADMINISTRATIVE LAW, HAVE ALL LEGAL SYSTEMS LEARN AND PRACTICE IN ACCORDANCE WITH HIGH COURT OF AUSTRALIA RULINGS, AND INTERNATIONAL LAW. MAGNA CARTA, HABEOUS CORPUS, AND FEE SIMPLE SHOULD BE INCORPORATED INTO ALL LAW IN AUSTRALIA. OUR CONSTITUTION SHOULD BE ADHERED TO AND A BILL OF RIGHTS INCORPORATED INTO THE CONSTITUTION. THE FIRST EIGHT SECTIONS OF THE CONSTITUTION ARE A BRITISH DOCUMENT, THOSE SECTIONS SHOULD EITHER BE REPEALED OR REMOVED AND OUR CONSTITUTION REBUILT. COURTS AT STATE LEVEL DO NOT LISTEN TO ANY OF OUR ARGUMENTS REGARDING FEDERAL OR CONSTITUTIONAL QUESTIONS. THE LEGAL PROFESSION DO NOT LEARN FEDERAL LAW OR CONSTITUTIONAL LAW, INTERNATIONAL LAW IS IGNORED, BECAUSE THEY SAY IT DOES NOT APPLY IN AUSTRALIA. A BACHELOR OF ARTS DEGREE IS THEIR KNOWLEDGE OF LAW. AS WE FINALLY MOVE TOWARDS A REPUBLIC AND GROW UP THEN IT IS OVERDUE THAT WE REMOVE ALL THAT IS BRITISH FROM OUR LEGAL SYSTEM. WE CANNOT BE PARTY TO INTERNATIONAL LAW WHILE WE REMAIN UNDER A FOREIGN LEGAL SYSTEM, EVEN OUR NATIONAL FLAG HAS TO LOSE

THE UNION JACK , AND BECOME A PROPER NATIONAL FLAG. THE LEGAL SYSTEM IS NOW OUT OF THE REACH OF DISADVANTAGED IN SOCIETY , THIS IS DENIAL OF NATURAL JUSTICE . LEGAL RIGHTS IS THE BASIS OF THE DEMOCRATIC SYSTEM. WE SHOULD NOT BE PENALISED BECAUSE WE ARE POOR , OR DISADVANTAGED , OUR CONSTITUTION COULD BE THE BEST LEGAL DOCUMENT IN THE WORLD . WE COULD BECOME THE GREATEST REPUBLIC IN HISTORY , ITS OUR DESTINY. YOU THE ELECTED REPRESENTATIVES OF THE GOVERNMENT (THE PEOPLE) HAVE THE OPPORTUNITY TO BECOME STATESMEN , BY USING THIS CHANCE TO HELP REBUILD THE LEGAL SYSTEM USING INTERNATIONAL LAW , THE AUSTRALIAN CONSTITUTION , THE HIGH COURT RULINGS AND PROPER LEGAL TRAINING OF THE LEGAL PROFESSION. DESPITE ALL LAND TITLE HAVING THE WORDS (ESTATE IN FEE SIMPLE) NO ONE IN THE REAL ESTATE INDUSTRY , OR THE COURTS OR LEGAL PROFESSION UNDERSTAND ITS MEANING. THE HIGH COURT RULINGS ON THE SUBJECT ARE IGNORED , SECTION 25 OF THE 1903 JUDICIARY ACT STATES THAT ALL HIGH COURT MUST BE ENFORCED , THE CONSTITUTION IS ALSO IGNORED DESPITE FEDERAL LAW . SECTION 24AA . THE LEGAL SYSTEM AT LOWER LEVEL DO NOT RESPECT ANY SUPERIOR LAWS , OR THE HIGH COURT . THE FEDERAL SYSTEM SHOULD PREVAIL AND THE INFERIOR SYSTEM BE ABOLISHED . THIS EXECUTIVE FULLY SUPPORT REAL LAW SUCH AS FEDERAL , CONSTITUTIONAL AND INTERNATIONAL LAW , WE DO NOT SUPPORT SO CALLED STATE LAW OR ADMINISTRATIVE LAW , WHICH IS PRACTICED BY LOCAL GOVERNMENT , 3RD OF SEPTEMBER 1988 THE GOVERNMENT (THE PEOPLE) WERE ASKED IN A FEDERAL REFERENDUM TO RECOGNIZE LOCAL GOVERNMENT IN THE CONSTITUTION , ALL STATES SAID NO , SECTION 128 OF THE CONSTITUTION STATES THAT NO STATE CAN ENACT A LAW NOT RECOGNIZED , YET DESPITE THE GOVERNMENT (THE PEOPLE) SAYING NO , THE SOCIALIST PARLIAMENT UNDER BOB HAWKE INTRODUCED THE 1993 LOCAL GOVERNMENT ACT , OF COURSE ONE COULD EXPECT LABOR PARLIAMENTS TO CARE ABOUT BEING ONLY A PARLIAMENT AND NOT THE REAL GOVERNMENT , THAT IS WHY THE PEOPLE NOW HAVE A VOICE CALLED THE AUSTRALIAN PATRIOT MOVEMENT NATIONAL EXECUTIVE , WE CALL ON THE PRESENT LABOR PARLIAMENT TO BREAK WITH THE PAST AND TO RECOGNIZE THE PEOPLE AS THE GOVERNMENT. YOU CANNOT EXPECT SOCIETY TO ABIDE LAW IF YOU THE PARLIAMENT WON'T ABIDE BY THE CONSTITUTION IN RELATION TO FRAMING REAL LAW. WE THE EXECUTIVE WISH TO THANK THE COMMITTEE FOR ALLOWING US TO COMMENT.
