BHP Billiton to give evidence for FIFO Inquiry in Adelaide

BHP Billiton will appear before the Regional Australia Committee in Adelaide on Thursday to give evidence for the FIFO/DIDO workforce inquiry. They will give evidence on their operation of the Olympic Dam mine, which employs both a residential and non-residential FIFO workforce.

The Committee will also hear from Mining Family Matters about the costs and benefits for families of FIFO workers. In their submission, they stress the importance of families having the right to flexibility of choice as well support for both FIFO workers and their families. Stating in their submission that, "both [FIFO and residential relocation] have their pros and cons and families should be supported whatever choice they make."

The Committee will also hear from industry representative bodies, including: the South Australia Chamber of Mines and Energy, Business South Australia and the South Australian Freight Council, regarding the concerns of their members and the industry's position on FIFO workforces.
