Rio Tinto to appear before Regional Australia Committee in Melbourne

The Regional Australia Committee will conclude its Victorian public hearings by receiving evidence from a wide range of witnesses in Melbourne regarding the use of FIFO/DIDO workforce practices in Regional Australia.

Rio Tinto in its submission, describes FIFO/DIDO workforce practices as, 'an increasing and essential feature of resources sector operations in Australia for the foreseeable future' and warns that, 'any move to arbitrarily limit FIFO/DIDO or to compel companies to base residential workforces in locations that may not be optimal would seriously impact the sector's ability to meet its labour needs and in some cases threaten project viability.'

The Chair, Mr Tony Windsor MP, said, 'The Committee has travelled all across Australia from the Pilbara to the Bowen Basin to Roxby Downs. We have received invaluable evidence and insights from the communities and organisations that have appeared before this Committee all of which will be essential in the consideration and formulation of recommendations for this inquiry.'
