### **Foreword**

This Delegated Legislation Monitor for 2004 is a consolidated edition of all of the Monitors that are produced in respect of each sitting week of the Senate during the calendar year. The format of the consolidation is similar to that of the weekly Monitors, setting out details of all disallowable instrument of delegated legislation tabled in the Senate. These details include the enabling Act under which each instrument is made, the date it was made, the date of tabling in the Senate and House of Representatives, the Department of State through which the Minister administers the enabling Act, and a short summary of its subject matter.

During 2004 a total of 1749 disallowable instruments were tabled in the Senate. These instruments were made under the authority of 219 separate enabling Acts, administered by 17 Departments of State.

Of the 1749 instruments tabled in 2004, 429 or 24 per cent, were in the Statutory Rules Series. Regulations in this series are made in accordance with the *Statutory Rules Publication Act 1903*.

The Monitor contains the following information:

- Departmental statistics;
- Enabling Act statistics;
- Alphabetical listing by portfolio of all instruments, including tabling dates and a short summary of subject matter; and
- Index to all instruments.
