STATEMENT TO THE SENATE

Senator Ross Lightfoot Senator for Western Australia

In July 2004 I visited Northern Iraq via Amman, Jordan. I went to Baghdad and from there to Arbil.

My visit was sponsored by Professor Robert Amin, Professor of Petroleum Engineering at Curtin University in Perth, Western Australia. Professor Amin is Director of that University's Woodside Hydro Carbon Research Facility. He is a leading member of the Iraqi Kurdish community in Australia.

I have had a long term interest in the mining and petroleum industries having had extensive and direct interests in my pre-parliamentary days. As is recorded in my Statement of Pecuniary Interests to the Senate I retain a portfolio of shares, including mining and petroleum shares.

I have also had a longstanding interest in the Kurdish people, their history and culture and my friendship with Professor Amin has deepened that interest particularly over the last two or three years given the turbulent and difficult period Iraq has been through.

I am of course also the President-elect of the Australian Iraqi Parliamentary Friendship Group.

During last year's visit to Arbil I visited a hospital in the company of Professor Amin and Mr Simko Halmet, an Australian citizen of Kurdish descent who is the Kurdish Regional Government and Patriotic Union of Kurdistan representative in Australia.

We visited a hospital administered by the Kurdish Regional Government at Halabjae. This city had been subjected to brutal attack including the use of chemical weapons by Saddam Hussein's forces in 1988.

While the Kurdish Regional Government was doing all it could to provide services, facilities and medical care it was apparent that they required additional assistance.

Following my inspection of the hospital facilities and the children's wing I indicated that I would try and help them to improve their resources.

Professor Amin and Mr Halmet and I discussed the situation in detail and agreed to do what we could to help. Frankly I was deeply moved by what I saw.

On our return to Australia Professor Amin arranged for a donation from the Woodside Hydro Carbon Research Facility at Curtin University. As the name indicated that centre is supported by Woodside Petroleum a major Western Australian company. Woodside has publicly attested to that fact.

In their press release today Woodside state:

"in October 2004 Woodside agreed with Perth's Curtin University to provide \$US20,000 to the Halabjae hospital in Northern Iraq, using funds from the University's Woodside Hydro Carbon Research Facility. The hospital treats children of victims of the 1988 gas attacks on Iraqi Kurds".

That donation was properly made to the Kurdistan Regional Government representative in Australia, Mr Halmet, to forward to the KRG for use in assisting the hospital.

This year in January I took a parliamentary study tour to the region. The tour was applied for and authorised in the usual manner. I paid for the costs of my travel with the KRG providing local assistance including security in what is a dangerous part of the world. I will in due course be reimbursed for the costs of my travel in accordance with the requirements of the parliamentary travel study entitlement.

I traveled to Dubai where I met with Mr Halmet who had independently traveled there from Sydney where he is based.

On my return I provided a detailed report.

I now want to turn to the grossly defamatory and completely untrue allegations made about me in a number of the news media including statements that I had forcefully denied to them prior to publication.

Later today I will be issuing instructions to my Solicitors.

I did not take \$US20,000 in cash with me to Iraq. The only money I took with me was \$US1,000 of my own money for personal expenses. I have a receipt.

At no stage have I ever received nor have I carried, nor have I given to the Kurdish Regional Government or the PUK or any agent or officer thereof \$US20,000.

As my report indicates I was present at a meeting with the Prime Minister of the Kurdish Regional Government, Mr Omar Fatah, where we discussed a number of important issues about the future of Iraq including a possible federal structure for its government.

At that meeting Mr Halmet the Australian representative of the KRG passed the donation from the Woodside Hydro Carbon Research Facility to the Prime Minister who in turn gave it to his Principal Secretary.

A written acknowledgement of the donation was subsequently received by Mr Halmet who forwarded it to Woodside. That document was issued in the name of the Minister for Health of the Kurdish Regional Government. I am advised that the acknowledgement stated the donation would be used for services and facilities for the hospital I visited.

Later that morning Professor Amin rang me from Perth and I told him that the donation to the hospital had been presented to Prime Minister Fatah.

At no stage did the money ever come into my personal possession. Indeed I did not know until Mr Halmet gave it to the Prime Minister that he either had the money in his possession or was going to make the presentation at that meeting.

As noted in my report it is true that a photograph was taken with me and some friendly Iraqi national guard soldiers. They were brave young men serving their country in very difficult circumstances who had been allocated to me for my security. I do not believe that my actions were inappropriate.

As also noted in my report I was offered the use of a .38 pistol by my Iraqi National Guard detail. They were obviously genuinely concerned for my safety. While I did take the weapon from them I was uncomfortable with it and did not subsequently carry it. Indeed I left it secured in one of the vehicles in which I was traveling.

As will also be noted in my report I encountered a very long and tedious process in dealing with Customs officials on the Iraq/Turkey border. This process took two and a half hours and artificial delays occurred.

I should emphasise that I fully complied with all the proper processes and was not carrying any items that would give rise to legitimate inquiry. Notwithstanding this fact progress was negligible until I was asked to pay \$US20 by a Turkish official who then processed my papers and I was able to pass through promptly.

I turn now to the completely untrue allegation that my actions in assisting a hospital in Halabjae was motivated by my modest holding of 875 Woodside shares or that I subsequently sold those shares because of media interest in this matter.

I regularly trade shares. I bought the shares in November last year and sold them last Tuesday. I properly declared the purchase of the shares and their purchase and disposal was made in the normal course of my trading activities.

Any examination of my Pecuniary Interests returns would show that I have had a longstanding share trading portfolio.

I completely reject as ludicrous and offensive the suggestion that a modest holding of shares in Woodside, a major Western Australian company, which forms a small part of a much larger portfolio, in any way motivated me in my actions to assist this hospital.

In summary I have at all times acted honourably and properly in this matter and I reject completely the allegation that I have acted in any way wrongly or out of self-interest.

On 23rd May, it was brought to my attention that my Register of Senators' Interests reflected a number of anomalies in that I had not disclosed the purchase of several parcels of shares, yet notified you of the sale of the same, and also omitted to disclose the sale of a quantity of shares that had been registered.

Given this deficiency, I have sought professional advice from both my accountants and stockbroker in regard to implementing a procedure to ensure that future trading activities will be accurately reflected in my Register of Senators' Interests and in a timely fashion.

It was never my intention to not disclose these holdings, as can be seen from the fact that I disclosed the sale of shares, (Amcor, Ceramic Fuels, WMC) that I had inadvertently omitted to register and that, in some instances, (Macquarie Airports, QBE, Telstra and Aztec) I failed to disclose that I no longer held shares that I had, in fact, registered.

In the case of Clinical Cell Culture, when endeavouring to comply with the reporting measures, a quick inquiry with my stockbroker as to my sales during the month of March 2005, included Clinical Cell Culture but did not reflect that only a portion of the company's holding had been disposed of. It was therefore mistakenly reported as a deletion when, in fact, I had retained a portion of the stock.

I have, at all times acted in good faith and any lapses have been entirely inadvertent.

Although my files are still with the accountant, attached is a new form reflecting what I understand to be an accurate accounting of current holdings.

You will note that there have been several additions as well as deletions during the last several weeks. Should information provided by my accountant or stockbroker identify any other relevant issue, I shall advise you forthwith.
