

## Alteration of statement of registrable interests

As you would be aware, I have the honour of being appointed the Minister for Justice and Customs. In order to comply with the Ministerial requirements for the divestment of private interests which may pose a conflict of interest, I have instructed my solicitors to:

- review my financial position with a view to complying with the letter and spirit of those requirements;
- (b) prepare the necessary documentation to effect the divestment of those interests;
   and
- subsequently prepare the necessary documentation to notify you of the changes to my registrable interests.

My solicitors have completed a preliminary review of my financial position. Although time will be required to consult further with my solicitors and to prepare the necessary documentation, I can foreshadow that changes to my registrable interests will include:

- Disposal of most, if not all, of my relevant interests in shares.
- Resignation from all directorships and other positions as company officer.
- Resignation from all trusteeships.

Some of these changes have already been effected. For example, I have already resigned as director of New Millennium Resources Limited and resigned as co-trustee of the Butterworth Trust.

A significant number of my relevant interests in shares arises through my ownership of shares in the company Alethia Pty Ltd. I intend to dispose of my interest in Alethia Pty Ltd. Unfortunately, Alethia Pty Ltd holds restricted securities in the listed public company Abra Mining Limited. As a condition of receipt of those restricted securities, both Alethia Pty Ltd and myself executed a restriction agreement with Abra Mining Limited by which it is effectively agreed that until 8 April 2007 I will not dispose of my interest in Alethia Pty Ltd. Rather than wait for the escrow period to expire, I have instructed my solicitors to seek the consent of Abra Mining Limited (and the Australian Securities Exchange) to change the restriction agreement to allow me to dispose of my interest in Alethia Pty Ltd. Until the consent of Abra Mining Limited and the ASX is forthcoming or 8 April 2007 I am prohibited from disposing of my interest in Alethia Pty Ltd.

I trust that this letter will suffice as an interim explanation of my position until I can give formal notification to you of the change in my registrable interests.






