Re: Asia Pacific Claims Management Pty Ltd

Thank you for taking the time to speak yesterday with my Chief of Staff regarding the issue with respect to publishing details on my register concerning a corporation where, whilst I have not directly held shares in the company, I did have an interest in another corporation which held an interest.

The company in question never traded. The company never had any clients or employees, reported no income or expenditure (other than compliance payments ASIC etc), and in every sense never functioned.

The company was established to endeavour to carry on the work which had been previously undertaken by another corporation which was and always has been published on my register.

Notwithstanding, there is an argument that whilst I held no direct interest in a company which did not function or operate and was deregistered over twelve months ago, my potential beneficial interest through another corporation may support the argument that it should have appeared on the Senators' Interest Register up until its dissolution on 17 May 2017.

For completeness I would appreciate if you would publish this correspondence on the register. In making the declaration it is worth noting that all details pertaining to the company were publically available as it was recorded on the register of the Australian Securities and Investments Commission (ASIC).

In the interests of transparency, I would state to interested parties that they have always had the ability to publically examine details of that company via that medium.

Thank you for your advice regarding this matter.
