Senator McCARTHY: Yes, if you can give the outbreak areas and also this task force? Ms Appleyard: Oh, yes, the Multijurisdictional Syphilis Outbreak Working Group is coordinated by my division of the Department of Health, the Office of Health Protection. Senator McCARTHY: And where are they located? Ms Appleyard: We are located in Canberra, but of course there are representatives located in states and territories, because it is the Commonwealth doing national coordination of state and territory activity. Senator McCARTHY: And when was that group put together? Ms Appleyard: In 2014, and, as I mentioned, it meets monthly. Senator McCARTHY: So how long has the department been aware of this outbreak? Ms Appleyard: The first indications of the outbreak commencement were in January 2011, but I would say at that stage—and I might have to take it on notice—it may not have been identified as an outbreak per se.
