Senator McKim asked the following question at the hearing on 17 October, 2016:

Ms Saunders: If I could add to that, in terms of the observations made, in terms of potential deficiencies, it has not been just addressed through mentoring the individual investigators through the matter that they might be investigating. There has been a whole range of training delivered in response to that. I am happy to provide this list to you. Since 2013 there have been 32 different training programs delivered, in a whole range of areas, to enhance the capabilities of Nauruan police, including vulnerable-witness programs, how to investigate sex offences, in terms of sexual offence first-aider response courses, basic investigative programs, and the list goes on. So there has been significant effort made in enhancing their capacity.

Senator McKIM: I will ask for that to be provided on notice, if that is okay.

CHAIR: This is tuition requested by the Nauruan police, I assume?

Mr Colvin: Certainly it is done in consultation with them. We do not provide training that they do not want us to provide, and we will provide that to the committee. The point I would make, though, is that is training that my officers get as well. It is training that my state and territory counterparts—it is a constant ongoing procedure.

The answer to the honourable senator's question is as follows:

The AFP has provided or facilitated training for the Nauru Police Force. This includes training that was delivered as a result of findings and recommendations from the *Review into Recent Allegations Relating to Conditions and Circumstances at the Regional Processing Centre in Nauru 2015* (known as the Moss Review). All training has been developed and delivered in consultation with the NPF.
