**Senator Cormann:** ...

That will be updated again in the next budget, to be delivered on the second Tuesday in May. At this point, given the work that we have undertaken so far, including having implemented more than \$250 billion worth of net budget improvement measures over the period to 2026-27, since we have come into government—

**Senator GALLAGHER:** Can we have a list of those?

**Senator Cormann:** We have provided that before but I am happy to provide it again.

**Senator GALLAGHER:** It must be a growing list, because I have not heard \$250 billion—since you came into government, in 2013.

**Senator Cormann:** Since we came to government in 2013. I have mentioned this figure before. I have been asked a question before and I am very happy to provide the information again on notice.

**Senator GALLAGHER:** I note in your speech to The Sydney Institute that it was \$221 billion—

**Senator Cormann:** There has been more now. The FOI request was for a briefing note to me. That was not—

**Senator GALLAGHER:** I think it was about trying to get to the list of the decisions that have been—

**Senator Cormann:** Well, I can take it on notice. I am quite happy to provide that information on notice.

**Senator GALLAGHER:** Okay—up to the cumulative total of \$250 billion. Thank you.

**Answer:**

There are over 1,100 expense and non-tax revenue measures that contribute to the net budget improvement of approximately \$250 billion over the period 2013-14 to 2026-27.

Attachment A lists the measures with the largest positive or negative impact on the fiscal balance (\$100 million or more) over the period 2013-14 to 2026-27.
