Answer:

The final funding amounts allocated by Primary Health Networks (PHNs) through the Indigenous Mental Health Schedule to Aboriginal Community Controlled Health Services (ACCHS) are finalised at the end of the financial year. As a result, an overview of the finalised amounts for 2020-2021 is not yet available.

Confirmed figures for the 2019-2020 period can be provided. In 2019-2020, \$29.1 million (GST exclusive) was allocated to PHNs for the commissioning of Indigenous Mental Health services. \$20.7 million (GST exclusive) was provided to ACCHS to deliver these services (in 2019-2020). The remaining funding was allocated to other service providers with a small percentage allocated to core operational expenses incurred by the PHNs.

Figures for 2020-21 can be provided later this year, following the receipt and assessment of PHNs audited financial statements and 12 Month Performance Reports. **PHN Indigenous Mental Health Funding to ACCHS**

There are commercial-in-confidence contractual arrangements in place between PHNs and ACCHS that prevent the public release of confidential information, including individual funding amounts. The Department of Health is unable to provide a breakdown of the PHN Indigenous Mental Health funding provided to each individual ACCHS. Briefings on individual ACCHS can be provided directly to committee members on a case by case basis if required. Total funding provided to ACCHS by State and Territory is outlined below.
