Question:

- a) Are you still expecting 180 more Health Care Homes from 1 December?
- b) How many of the 200 practices that you shortlisted to be Health Care Homes have now pulled out of the trial?
- c) How many of those have actually signed deeds/contracts to become Health Care Homes on 1 December?
- d) Is it correct that there is only \$2.5 million in expenditure allocated to Health Care Homes next financial year? How will that be expended?
- e) What is the financial incentive for practices to participate in the Health Care Homes trial?

Answer:

- a) On 1 December there were 190 practices enrolled. Additional practices are expected to enrol in the coming weeks.
- b) Of the original 200 shortlisted practices, 61 did not proceed with the trial. A number of these have been replaced by other shortlisted applicants.
- c) Of the original 200 shortlisted practices, 139 have formally signed agreements to participate. Fifty-one additional practices have signed formal agreements.
- d) \$114.3 million has been allocated to the Health Care Home stage one trial over four years from 2016-17 to 2019-20. Approximately \$61 million is allocated in 2018-19. This money will be used for clinical services and infrastructure support.
- e) Participating practices receive an up-front \$11,000 (GST inclusive) incentive grant and a bundled monthly payment linked to each enrolled patient's level of complexity and need, with the highest amount paid for the most complex and high-need patients. Bundled payment values are:
 - Tier 3 - \$1,795 per annum (highest complexity)
 - Tier 2 - \$1,267 per annum
 - Tier 1 - \$591 per annum (lowest complexity)
