Senator KIM CARR: Of course, I expect that. That's not unreasonable. Mr Joske's accused 59 of our scholars. Have you got files on all the 59? Ms Emery: We don't know who the 59 are, so-

Senator KIM CARR: Many of them were published on the front page of the Australian. Surely you have files on those.

Ms Emery: If we're talking about the article on 24 August last year, I think there were 32 allegations-32 researchers who were named-who weren't all funded by the ARC.

Senator KIM CARR: You've kept files on all of those? Ms Emery: They do come up as a list of our potential sensitivities and, as I was talking about before, we're happy to go through the process we undertook at that time if that's of help. Senator KIM

CARR: I just want to know: have you kept files on the 32 who received ARC grants?

Ms Emery: They've been named as a sensitivity- Senator KIM CARR: So the answer is yes? Ms Emery: and we undertook further investigations. Senator KIM CARR:

Have you found any breaches of any of their grants? Ms Emery: I can advise that 31 of those 32 relate to researchers who have been, at some time, named on an ARC grant and that could be some time from quite a way ago- Senator KIM CARR: Have

been acquitted some years ago? Ms Emery: Yes, some years ago, so the grants would have been finalised. We have finalised 30 of those cases and there are two cases

ongoing. Senator KIM CARR: And you're still inquiring into the two-that's what you mean by 'ongoing'? Ms Emery: It means working with the institution in relation to

those cases. Senator KIM CARR: Of the 30 that you've finalised, have you found any issues with the 30? Ms Emery: I'd need to take that on notice. Senator KIM CARR:

You've told the JSI that there are no issues. Was that correct or not? Ms Emery: Well, Senator, that was a couple of months ago and I think since then there have been a few cases which have been finalised, so I need to take it on notice. Senator KIM CARR: Is it the case that-did you tell JSI that, of those that you finalised-the 30 that you'd finalised-there were no issues?

Ms Emery: I think that was in relation to national security, Senator.

Senator KIM CARR: I see.

Ms Emery: I just want to clarify that, at the time the joint inquiry hearing, I do believe that we still had a few outstanding-

And you've now indicated in your investigation that in 30 of the 32 there are no issues-or certainly that's what you presented to the joint committee-and I'm wondering has there been any change in that status?

Ms Emery: As I explained, there have been no national security issues identified but I'm taking on notice the detail of whether there are other issues identified.

## **Answer**

**The Australian Research Council (ARC) has provided the following response.**

All 31 allegations relating to researchers named on an ARC grant have now been resolved. Three issues relating to two researchers were identified and action taken.
