Voluntary Mental Health Check Tool

Question

Answer

- 1. The Voluntary Mental Health Check Tool (also known as My Mind Check) was ready for use in all jurisdictions in Term 2, 2024.
- 2. Through the Student Wellbeing Boost, \$10.75 million was allocated for the Voluntary Mental Health Check Tool. A total of \$10.5 million has been expended for development and implementation, with the remaining \$250,000 to be expended as the project progresses.
- 3. As of 22 November 2024, 986 schools have registered their interest to use the Voluntary Mental Health Check Tool, with 32 schools across 6 states/territories and the Catholic and independent sectors having registered for its use.
- 4. Student data collected by My Mind Check will not be disclosed outside of individual schools, with only authorised school staff to access student data collected at their school. These staff can only view students' aggregated indicators and do not have access to individual answers to questions. Schools' use of this data is subject to privacy obligations as noted under the Terms of Use agreement accepted by schools to use My Mind Check.

In order to provide technical support to participating schools, a limited number of authorised Macquarie University project staff have access to the data. Macquarie University staff access to this data is in accordance with contractual and privacy obligations.

As part of the contractual reporting obligations, Macquarie University will provide a final report to the Australian Government Department of Education in May 2025. This will include statistical uptake and usability data including the number of schools per jurisdiction and the proportion of government and non-government schools that have opted to participate. This will not include the name of individual schools or student information. The report will not include any student mental health and wellbeing data or analysis.
