Agreement with state and territories to fund 500,000 Fee-Free TAFE

Question

The Commonwealth entered into an agreement with the states and territories to fund 500,000 Fee-Free TAFE and vocational education and training (VET) places across Australia over 2023 to 2026.

- 1. What is the total amount of funding that has been allocated to this program since its inception?
- 2. How much of the Commonwealth funding has been expended since the program commenced (annualised)?
- 3. Can the Department advise:
- a. the total number of fee-free places have been taken up each year since the program was announced?
- b. which category or area of the ten stated national priorities those fee-free places fall under?

Answer

- 1. Through the Fee-Free TAFE Skills Agreement, the Commonwealth Government, in partnership with state and territory governments is delivering over \$1.5 billion in funding for 500,000 Fee-Free TAFE and vocational education and training (VET) places across Australia over 2023 to 2026 in partnership with states and territories. This includes Commonwealth investment of:
 - \$493.3 million for 180,000 Fee-Free TAFE places in 2023 (Tranche 1)
 - \$414.4 million for 300,000 Fee-Free TAFE places over 2024-2026 (Tranche 2)
 - \$86.4 million for 20,000 Fee-Free TAFE construction places over 2025-2026 (Fee-Free Construction).

The Commonwealth is contributing almost \$1 billion of the overall \$1.5 billion investment to deliver Fee-Free TAFE with states and territories.

- 2. \$658.9 million of Commonwealth finding has been expended as at 20 June 2024
- a) 508,889 Fee-Free TAFE enrolments as at 30 June 2024.
