### **Question 6**

**Outcome: All Program: All Topic: Veteran Family Advocate** (FADT Hansard Proof 2 June 2021, p 107)

#### Answer

In a significant step towards promoting better outcomes for veterans' families, Commissioner Gwen Cherne was appointed as the first Veteran Family Advocate, commencing in the role on 24 August 2020. Commissioner Cherne is appointed as a Commissioner to the Repatriation Commission and the Military Rehabilitation and Compensation Commission and represents the perspectives of veterans' families in ongoing policy and decision making across government.

The Veteran Family Advocate has appropriate resources to fulfil her role of providing strategic advice to Government for veteran and their families. The Veteran Family Advocate is supported by an Executive Assistant, a Project Officer, and the Department of Veterans' Affairs (DVA) and providing a Family Support Officer to help manage welfare issues.

The Veteran Family Advocate is also supported indirectly by the resources of the department through providing pathways for veterans and their families to access a range of support services

including case work, counselling and peer support through the Triage and Connect, Open Arms – Veterans' and Families Counselling (Open Arms) and Wellbeing and Support Programs. DVA and Open Arms assist by providing rapid responses to emerging welfare events and clinical outreach supports to veterans and their families referred by the Veteran Family Advocate.

When the Veteran Family Advocate has a concern for the mental health and wellbeing of a veteran or family member, a request is raised for an urgent reach-out call, via the 24/7 Open Arms Client Assist Contact Centre. The team follows up and coordinates support from within DVA and appropriate external community health services.

Between April and May 2021, the Veteran Family Advocate co-chaired Open Arms Regional Advisory Forums in Adelaide, Townsville, Sydney, Hobart and Brisbane. Commissioner Cherne met with individual stakeholders and key organisations in the veteran community on mental health and wellbeing priorities. These visits will continue as COVID-19 restrictions permit.

Since appointment, the Veteran Family Advocate has engaged in more than 7,600 instances of verbal and written communications with veterans and/or their families including phone calls, emails, letters, text messages, social media, presentations and meetings. The meetings consist of government entities: (e.g. The Minister, Defence, Navy, Army, Airforce, DVA, Open Arms, National Mental Health Commission), Ex-Service Organisations and Roundtables.
