Travel exemption data cannot be disaggregated by visa subclass prior to 1 August 2020, when processing of travel exemption requests moved to the Travel Exemption Portal. Therefore, the table below provides the requested information for the period 1 August 2020 – 28 February 2021 inclusive and does not include any approvals between 20 March 2020 – 31 July 2021.
