Senator Stirling Griff asked:

How many people who were transferred to a regional processing country on or after 19 July 2013 are currently in Australia?

Of these:

- b. How many are currently in an Alternative Place of Detention (broken down by State/Territory)?
- c. How many are currently under a Residence Determination and in 'community detention' (broken down by State/Territory)?
- d. How many are currently residing in the community on a Bridging visa? (broken down by State/Territory)?
- e. How many are unlawful and living in the Australian community without a valid visa (broken down by State/Territory)?

*Answer:*

As at 31 January 2021, there are 1,161 people who were transferred to a regional processing country since 19 July 2013 currently in Australia.

Of these:

- a. 111 people were in an Immigration Detention Centre (IDC) or Immigration Transit Accommodation (ITA)
