Table 1 details the number of on-hand Partner and Child visa applications as at 31 October 2022 as well as median processing times, which reflect the age of applications finalised in October 2022.

Other Family and Parent programs

Parent and Other Family visas are subject to capping and queuing arrangements. The Department processes Parent and Other Family applications in date order and within annual caps.

As at 31 October 2022, the Department has released for final processing:

- Contributory Parent visa applications with a gueue date up to December 2016
- Parent visa applications with a queue date up to February 2011
- Aged Parent visa applications with a queue date up to December 2012
- Remaining Relative visa applications with a queue date of up to 31 July 2012
- Aged Dependent Relative visa applications with a queue date up to 31 July 2012
- Carer visa applications with a queue date up to 26 July 2018.

The Department provides the following information regarding processing time estimates on its website (as at 31 October 2022).

- Contributory Parent visa (subclasses 143, and 864) applications lodged that
 meet the criteria to be queued are likely to take at least 74 months to be released
 for final processing.
- New Parent (subclass 103) and Aged Parent (subclass 804) visa applications lodged that meet the criteria to be queued are likely to take at least 30 years for final processing.
- Carer visa applications that meet the criteria to be queued are likely to take approximately 7 years to be released for final processing.
- Remaining Relative and Aged Dependent Relative visa applications that meet the criteria to be queued are likely to take approximately 50 years.

These estimates are determined using the number of visa applications onhand and are based on current annual planning levels.

Table 2 details the number of on-hand Parent and Other Family visa applications as at 31 October 2022.

¹ Includes primary and secondary applicants. Onhand applications that are pending payment resolution are also included.

² Partner visa applications involve a two stage process, and the two applications must be lodged together. That is, the offshore Partner (Provisional) (subclass 309) visa is lodged with the Partner (Migrant) (subclass 100) visa; and the onshore Partner (Temporary) (subclass 820) visa is lodged with the Partner (Residence) (subclass 801) visa. The two applications are, in the majority of cases, decided at different times. To avoid double counting, only first stage Partner visa grants, which include subclasses 300, 309 (offshore) and 820 (onshore) visas, count towards the Migration Program.

³Second stage Partner applications (subclasses 801 Partner (Residence)) visa and 100 Partner (Migrant) visa generally become eligible for assessment (active) two years after lodgment of the combined first/second stage application.

⁴Processing times are unavailable due to a small number of applications finalised as at 31 October 2022.
