The SRSS program is funded through Program 1.3 Onshore Compliance and Detention. Total funding for this Program as per the Department's 2017-18 Portfolio Additional Estimates Statements is:

Question 3:

In line with Government and community expectations, the eligibility criteria for SRSS recipients is reviewed regularly. Changes that are currently being considered focus on people's capacity for self-agency (rather than being reliant on SRSS income support) and status resolution through granting of a visa or departure from Australia.

Question 4:

There will be no new tender process for SRSS. Two year contract extension clauses have been activated for nine of the existing eleven SRSS Providers.
